1. All promotion requirements including attendance, behavior and academic expectations must be fulfilled.
2. Eighth grade students will abide by all school rules and policies and realize that failure to do so may result in my loss of participation in eighth grade activities and/or the promotion ceremony.
3. Eighth grade students will earn a passing grade in LA and Math and demonstrate progress in all other classes. Failure to do so may result in the loss of promotion activities.
4. Eighth grade students will clear all outstanding discipline debts (detentions) by Friday, June 2nd, 2017 in order to participate in any eighth grade activity or the eighth grade dance.
5. Students will return or make payment for all library books, textbooks, equipment, and any owed lunch money by Friday, June 2nd, 2017
6. Eighth grade students will attend all promotion practices.
7. All students will abide by all school policies, rules and regulations, including dress code at the eighth grade trip, and any other eighth grade activity.

Finally, it is important for all parents to remember as your son/daughter gets closer to promotion that:

1. Any eighth grade student whose suspension prevents him/her from participating in the mandated promotion practices may not be permitted to participate in the promotion ceremony or eighth grade activities.
2. Any eighth grade student who willfully participates in activities which are destructive to school property or causes the District to expend money for clean up or repair shall be excluded from all eighth grade activities, including promotion. Transcripts and all school records will be held pursuant to this policy.
