The enclosed flyer is correct in the total amount of scholarships available for 2019 and in the deadline date of April 7, 2019. In celebration of California Coast Credit Union's 90<sup>th</sup> Anniversary, the Cal Coast Cares Foundation is providing \$90,000 in scholarships to high school seniors, foster students and area colleges in 2019.

The James L. McPheters California Coast Credit Union High School Scholarship Program is providing \$30,000 in scholarships. Four scholarships for \$2,500 each and ten scholarships for \$2,000 each will be awarded to college-bound high school seniors residing in San Diego or Riverside County.

In addition, the Cal Coast Cares Foundation is providing \$30,000 in foster student scholarships to college-bound high school seniors and current college students who are in or have been in the foster care program in San Diego or Riverside County. Each scholarship is \$2,000. Recipients in 2019 will also receive another \$2,000 in 2020 if they apply and continue to meet the eligibility requirements.
