

EXECUTIVE SUMMARY

The District continued, in 2018, to improve facilities across the District's campuses. Several notable projects were completed: The Career Technology Classroom building at Vista Murrieta High School, the parking lot expansion and addition of a portable restroom facility at Alta Murrieta Elementary School were among the largest.

The District continued to keep pace with the 10-yr. maintenance plan including HVAC Unit Replacements, Data Cabling, Roofing, Painting, Asphalt Paving Surfacing, Flooring, and ADA and playground upgrades at multiple campuses.

The results of last years assessments provided the nexus for the District to move forward in further clarifying the scopes of improvements at several campuses that would otherwise not be able to accept the coming enrollments or have conditions requiring more immediate remedy. Portable replacement and/or expansion projects have completed Schematic Design efforts to evaluate specific campus needs and more closely determine operational and cost impacts.

- Murrieta Mesa High School Classroom Expansion completes the campus' original intention for accommodating expansion with an 11-classroom addition.
- Murrieta Canyon Academy has developed into an exciting, 22- classroom, comprehensive solution to many specialty programs provided by the District.
- Murrieta Elementary School Expansion replaces 13 of the 23 portables currently in operation. The design includes renovated field areas, parking expansion, improved bus-drop area and outdoor student assembly space.
- Cole Canyon Elementary School Expansion replaces all existing portable classrooms in a two-story solution that includes improved lunch shelter, outdoor student assembly and field renovations.
- Shivela Middle School Expansion replaces 15 portable classroom building with a two-story 16classroom building. A culinary garden and Engineering Yard are included in the project scope.
- Thompson Middle School Expansion replaces portable classrooms and locker rooms with a two-story classroom building including Robotics and Drama suites. A locker building on the lower field provides better proximity to fields, provides restrooms to the fields for PE and community use.

The methodology for the assessments centered on focused campus reviews conducted at each site. Bill Olien, Lori Noorigian and Richard Nowicki, AIA, Partner visited each campus and met with each of the Campus' Principals. The meetings were focused on reviewing current classroom utilization and enrollment impacts due to the three primary areas known to be impacting classroom space.

The District has experienced an increase in the number of classrooms used for Technology Labs, Special Education Classrooms, and Intervention Programs required to meet enrollment and curriculum needs. As the needs for these areas have grown, core classrooms intended for regular instruction have been converted or re-purposed for these needs. The result is that almost all of the District's Campuses are making do with fewer classrooms, leading to larger class sizes and reduced flexibility to react to curriculum changes and advancements throughout the District.

PURPOSE

The 2019 Facilities Assessment continues the yearly assessment of needs at each campus to plan future improvements to better serve the students and communities served by the Murrieta Valley Unified School District. The Assessment identifies needs generated from the District's goals to address enrollment growth, upgrades to instructional and support facilities, and impacts of growth to specific programs.

The District has experienced an increase in the number of specialized classrooms required to meet enrollment and curriculum needs. Specifically, three areas have created the greatest overall impact:

- 1) Technology Labs,
- 2) Special Education Classrooms and
- 3) Intervention Programs.

Each of these areas has seen remarkable expansion in need and use over the recent years. As the needs for these areas have grown, core classrooms intended for regular instruction have been converted or re-purposed for these needs. The result is that almost all of the District's Campuses are making do with fewer classrooms, leading to larger class sizes and reduced flexibility to react to curriculum changes and advancements throughout the District.

The strategies and tasks required to develop the Facilities Assessments for the Murrieta Valley Unified School District has resulted in a challenging and complex undertaking. The District has generously committed time and resources from Site Administrators to the Assessment process - the focus and quality of their involvement reflect a strong District-wide commitment to this process. To complete the assessments we engaged in a focused process that reflects a short-line sequence of tasks to identify necessary steps to assure that each campus is equipped with the facility resources required to deliver the kind of world-class curriculum opportunities the Murrieta Valley Unified School District offers.

Criteria for Determining Project Priorities

Campus Improvements identified in the assessment were reviewed and approved by the District through a targeted planning process focused on the District's goals. Projects have been prioritized by the District based on facility conditions, level of impaction and availability of funding. The District established three criteria for determining project priorities:

- Enrollment projections, growth and space
- Instructional program goals and objectives
- Condition of buildings and utilization of space

PROCESS

Enrollment Projections

Projections through the 2028/2029 Academic Year were compiled by the District and supplied for use in this analysis. Each campuses need was evaluated for the ten year period 2019-2029. Doing so allows the district to distinguish between major and minor fluctuations in enrollment year over year. The District is then able to prioritize needed improvements based on long-term facility requirements.

Classroom Utilization

Each campus was reviewed in detail to identify how each classroom and/or Teaching Station is currently being used in terms on subjects, grade level, program use, etc. Nearly every campus in the District has converted a number of the available classrooms from general instruction to Intervention, Special Education, Technology, Administrative and other Student Services uses.

Classrooms are distinguished by construction type, and which are relocatable units both District owned and leased. Classrooms are generally classified into: Standard Classroom, Open Classrooms, Science Labs, Special Education (both mild/mod and mod/severe), RSP, Intervention, Child Care, Technology and Student Support. Other classroom types are specific to grade level such as Kindergarten and Pre-School at the ES's and Art and Career Tech at the upper grades for examples.

The capacity is calculated using the California Department of Education loading standards per grade levels and classroom uses. The 2028/2029 projects are compared to the capacity resulting in the determination of classroom need at each campus.

Site Investigations

Bill Olien, Lori Noorigian and Richard Nowicki visited each campus over the course of the fall term of 2018. Meetings were arranged with each site Principal. The meetings were focused on re-assessing the Utilization Analysis, enrollments, programs, classroom uses and unique campus conditions and potential solutions for expansion or growth where identified. Any additional campus facility concerns were reviewed and if a facility solution was necessary were added to the list of facility needs for that campus.

Cost Evaluation

For those campuses where scopes of work were identified through the assessment process, a preliminary cost assessment is included. Estimates are based on current market conditions. It is recommended that appropriate escalation and inflation factors be included when identifying implementation scheduling for each project.

Funding Opportunities

Through the current programs for obtaining State funding for MVUSD projects, districts are able to qualify for funding for New Construction and for Modernization projects. An in depth analysis of the District's Eligibility within the current program has been identified and included. New Construction Eligibility is calculated on a District-Wide basis; Modernization eligibility is specific to each campus.



CAMPUS

Alta Murrieta Elementary School, a California Distinguished School, serves students in Kindergarten through Grade Five. Alta Murrieta Elementary School opened in 1989 as the third elementary school in the Murrieta Valley Unified School District.

ENROLLMENT

The 2018/2019 enrollment of 876 students represents an increase of just two students over the previous year. However, enrollment is expected to increase steadily over 16% through the 2028/2029 School Year when enrollment is projected at 1086 students.

FACILITIES

The school has 53 classrooms, a multipurpose room, a professional development center, library, 3 computer labs, administrative offices, cafeteria, staff lounge and two play areas (one for kindergarten students and one designated for students in grades 1-5). Child care facilities for students in grades K-5 are located on campus in a separate room.

RECENT IMPROVEMENTS

- Asphalt slurry to parking lots and new bell and paging systems
- New Student and Staff Restroom Facility
- Renovated stage area into conference and storage in MPR

UTILIZATION:

Of the 53 classrooms and teaching stations at Alta Murrieta, 18 are District owned portables. The campus is currently operating with a large number of classrooms used for non-classroom functions. Fully five relocatable classrooms are used for Student Support Services. None of the spaces are fully utilized. Two other relocatable classrooms are used for RSP and Child Care. Two rooms, 911 and 912 are use for Staff development and PTA.

Four of the portable classrooms are located on the site separate from the permanent structures and the other portables. The location makes integration of the programs housed in these facilities difficult and is disjointed from the campus.





CAMPUS

Antelope Hills Elementary, the tenth elementary school in the Murrieta Valley Unified School District, opened in August, 2005.

ENROLLMENT

The 2018/2019 enrollment of 821 students is again slightly down from 2017/2018. Still, enrollment expectations continue to increase through the 2028/2029 School Year when enrollment is projected at 956 students.

FACILITIES

38 regular education classrooms and teaching stations, and 4 special day, a multipurpose room with a kitchen, three computer labs, a library, an outdoor eating area, an amphitheater, administrative offices, a health office, teacher workrooms, and two play areas; one for kindergarten students and one designated for students in grades 1-5. A child care facility for students in grades K-5 located on campus in a separate room.

RECENT IMPROVEMENTS

UTILIZATION

Classroom utilization is nearly 100% with no open classrooms available for expansion. The campus currently allocates 5 classrooms for Special Education, 3 classrooms for Technology labs and 1 for Intervention Programs. Neither of the two Mod/Severe Special Ed classrooms have restroom facilities within the classroom. Facilities are immediately adjacent to the classrooms.

The classroom analysis indicates the campus has four classrooms available to support the projected enrollments. The number of classrooms on campus, while sufficient for current programs and needs, will not be sufficient should the District decide to implement Class Size Reduction on the 1-3 grade level classes and Full-Day Kindergarten. If both GSA and FDK are implemented, two additional Kindergarten classrooms and 4 classrooms for Grades 1-3 will be required.

The campus has had to transform many small offices and storage rooms into Student Support spaces for Speech, Pysch, RSP, etc. Some of these functions could be grouped into Room 7 to better accommodate their needs and handle enrollment growth by returning classrooms to instructional use.

CAMPUS

Avaxat Elementary School, a California Distinguished School, serves students in Kindergarten through Grade Five. Avaxat, which means cottonwood, is the second elementary school to be opened in the Murrieta Valley Unified School District. Avaxat Elementary is located on the northern side of Murrieta.

ENROLLMENT

The 2018/2019 enrollment of 676 students is down from last year. Even so, enrollment is projected to increase significantly through the 2028/2029 School Year when enrollment is projected at 871 students.

FACILITIES

The school has 37 regular education classrooms and teaching stations, 2 special day classes, 1 multipurpose room, a library, computer lab, administrative offices, cafeteria, staff lounge and two play areas, one for kindergarten students and one designated for students in grades 1-5. Child care facilities for students in grades K-5 are located on the west side of campus.

UTILIZATION

Classroom utilization is nearly 100% with no open classrooms available for expansion. Of the 37 classrooms available on campus, 7 are used for non-instructional uses: student services or storage, or are used for non-loaded programs like Intervention, Early Childhood or RSP. Future enrollment growth can be adequately served by the existing number of classrooms. The implementation of Full Day Kindergarten and Class Size Reduction will necessitate two additional classrooms for grades 1-3 and one additional Kindergarten class.

Two of the existing Kindergarten classes are housed in classroom space designed for older students and are not contiguous with the rest of the Kindergarten Classrooms.



Buchanan Elementary, the eighth elementary school in the Murrieta Valley Unified School District, opened in August, 2001.

ENROLLMENT

The 2018/2019 enrollment of 942 is slightly up from 2017/2018. Enrollment is expected to continue to increase through the 2028/2029 School Year when enrollment is projected at 1063 students.

FACILITIES

The school has 59 classrooms, a multipurpose room with a kitchen, four computer labs, library, cafeteria, an outdoor eating area, amphitheater, administrative offices, a health office, teacher workrooms, and two play areas, one for kindergarten students and one designated for students in grades 1-5. Child care facilities for students in grades K-5 are located on campus in a separate room. The school site is also home to a State Pre-School program.

RECENT IMPROVEMENTS

HVAC Replacement Complete

UTILIZATION

Current class utilization is less than 100%. There is currently one classroom that is open and unused. At current capacity, the campus will be able to accommodate the number of students projected to enroll for the next ten years. However, 32 of the 59 classrooms on campus are portables.

The campus is currently using five classroom spaces for non-instructional programs, Speech, Counseling, storage, etc. The Student support programs are randomly distributed across the campus as space was available over time. The spaces for these functions were not designed for that purpose. The District could re-coup 4-5 more classrooms if these programs were consolidated into spaces designed for those needs and by providing a storage container for Library storage.

The existing Special Education Classroom used for Severely Handicapped students is inadequate. A classroom needs to be made available or reconfigured to have restroom facilities inside, or immediately adjacent to, the classroom.



UTILIZATION

Current classroom utilization is over 100%. The consistent enrollment increases create the need to replace portable classrooms with permanent construction. The District has begun design of a new 12 CR expansion that will include additional student services offices, expanded lunch shelter facilities, expanded and renovated fields and pre-school playground upgrades.

Lisa J Mails ES is one of the most recent campuses added to the District. Enrollment projections show little expected growth. Growth on this campus has primarily been due to a transfer policy that allowed the District to alleviate impacts at other campuses. Transfers can be managed to mitigate enrollment growth. Over time locally generated enrollment may exceed campus capacity resulting in either the need for increased capacity or a reduction in total transfers allowed.

The areas provided for student support services are adequate provided additional classroom are provided as enrollment increases over time. The overall classroom utilization is near capacity. One technology lab is used at the campus. The resource areas in each classroom building provide localized access to technology. The number of special education classrooms is significantly less than other District campuses. The addition of a Special Education Pre-School Program is to be included in the growth plan for the campus.



CAMPUS

Murrieta Elementary School opened in 1958 as the first school in what would later become the Murrieta Valley Unified School District. The school serves students in Kindergarten through Grade 5. Over the years classrooms, offices, and a cafeteria were added and a comprehensive modernization program was completed in 2002.

ENROLLMENT

The 2017/2018 enrollment of 892 is an 8% increase over 2016/2017. More significantly, the number of students is expected to increase an additional 40% through the 2028/2029 School Year when enrollment is projected at 1167 students.

FACILITIES

The school has 41 classrooms, a multipurpose room, cafeteria, library, 4 computer labs, administrative offices, a staff lounge and two play areas, one for kindergarten students and one designated for students in grades 1-5. Child care facilities for students in grades K-5 are located on campus in a separate room.


UTILIZATION

The number of existing portables and the density of their placement have created a congested and difficult to supervise campus. A new 13 CR building will replace a similar number of portable classrooms that will be removed over time from the campus. The classroom additions also creates the only large open space for gatheriing and student assembly not including playfields. Depending on future developments and school options, consistent enrollment could generate the need for an additional building to replace the balance of the relocatable classrooms and improve the kindergarten play areas.



The campus is comprised of 16 portables located some distance from the rest of the campus. The needs assessment addresses long-term solutions for this area including new classroom building and other site improvements. Current district priorities are focused on campuses of greater need. Interim measures have been identified as an alternate to the long-term solution.

Alternate Budget to beautify the building exteriors, provide water to select CR's, paint building exteriors, etc. of approximately \$500,000 will provide needed updating to these areas until permanent expansion is prioritized.

CAMPUS

Shivela Middle School opened in September 1990 with sixth and seventh grade students. Shivela was recognized as a California Distinguished School in May of 2001. Shivela, an Indian word meaning Sycamore Tree, was chosen by the school board in recognition of the many Native American tribes that inhabited our valley.

ENROLLMENT

The 2018/2019 enrollment of 1414 students is nearly identical to 2017/2018. Enrollment is expected to increase through the 2028/2029 School Year when enrollment is projected at 1570 students.

FACILITIES

Shivela opened with two relocatable offices, a staff lounge/workroom, relocatable restrooms, locker rooms, multi-purpose room and twenty-six classrooms, eventually expanding to fifty-one relocatable classrooms. The campus moved into the new Physical Education building in 1996. After many years of waiting for state and local funding, Shivela's permanent campus was completed and dedicated in April of 1998.

UTILIZATION

Due to the expansion of the Intervention programs and the conversion of classrooms to technology based labs, the number of classrooms available for core curriculum and instruction is impacted. Current capacity is less than enrollment. Any increases in enrollment will likely require additional classrooms than what is on-site currently.

A 16 classroom expansion is currently in design to replace portables and provide specialized spaces for CTE programs such as Robotics, AVID, Culinary and other programs.


UTILIZATION

The newest high school in the District is impacted. The current enrollment of nearly 2466 students exceeds capacity. Eight classrooms have been converted to Intervention or Technology labs. Existing Staff Development spaces have been converted to instructional use and an ROTC office. Whether in existing classroom space or in new construction additions to the campus, approximately 6 additional teaching stations will be required. The original Master Plan for the campus identifies the location for classroom expansion to be located where the existing Sand Volleyball courts are.

The District is in design for an 11 CR addition to the campus. The new building will be located where the original design anticipated expansion. In addition to general classrooms, the ROTC program will be moved from its current location and the vacated spaces retuned to instructional use.





CAMPUS

Murrieta Valley High School (MVHS), a California Distinguished School, is a four-year comprehensive high school fully accredited by the Western Association of Schools and Colleges. At its opening in 1990, MVHS was the first high school in the District.

ENROLLMENT

The 2018/2019 enrollment of 2255 students is down considerably from 2017/2018 when enrollment was 2390. Enrollments are expected to return to the high 2300 figure over the next ten years.

FACILITIES

The MVHS campus is housed on 52 acres and has 152 classrooms, computer labs, technology labs, photo labs, a video production studio, automotive shop, classrooms for ceramics, food classes, science labs, and a state-of-the-art performing arts center. Athletic facilities include a swimming pool, gymnasium, football stadium, soccer fields, a running track, softball fields and basketball courts. In addition, the school has a library, cafeteria, administrative offices, and a staff lounge.



CAMPUS

The first phase of Vista Murrieta High School opened in August 2003 for freshmen and sophomore students. The second phase of the school, including the Aquatics and Athletic Stadium, were completed in 2004. The school's first class of seniors graduated in June, 2006.

ENROLLMENT

The 2018/2019 enrollment of 3554 is up 3% from 2017/2018. Enrollment is expected to fluctuate minimall through the 2028/2029 School Year when enrollment is projected at 3549 students.

FACILITIES

The high school is built on 68 acres and overlooks the City of Murrieta. VMHS has 99 classrooms, computer and technology labs, library, college career center, state of the art science facilities, a lecture hall, classrooms for ceramics, art, fashion and design, photography, and foods and a performing arts center which includes band, choir and drama classrooms, offices for school administrators, staff, the school nurse, workrooms, an ASB office, student store and Athletic facilities include main and practice gymnasiums, an aquatics facility, athletic stadium with an all-weather running surface, three competition baseball and softball diamonds, two full-size soccer fields, physical education fields and courts, a weight room with state of the art equipment and classrooms for health, wrestling, and aerobics.

UTILIZATION

The new 2-story CTE classroom addition will provide an additional 3 teaching Stations by providing 13 new classrooms and removing 10 district-owned Portables and 2 leased ones. Project was recently completed and therefore costs are not included in this needs assessment.

The 'Tower' rooms intended for faculty use would alleviate pressure on classroom uses if reconfigured for Student Support Services such as Psychology, Speech, RSP and SDC uses. The Credit Recovery Program is impeding use of a technology lab. An alternate space should be provided. Although the campus will have sufficient teaching stations to meet the enrollment needs. The very high student population is also taxing Library, MPR, Gymnasium, Admin and Counseling Spaces. Future growth should be avoided on this campus.





CAMPUS

Murrieta Canyon Academy serves students in grades K through 12 in the Murrieta Valley Unified School District. Creekside High School opened in August 1998. In 1999, the District started an independent study program for students who needed something other than a traditional classroom setting. By the end of the 2002/03 school year, the demand for the independent study program had grown to the point where there was a waiting list of students. Tenaja Canyon Academy opened in 2003.

As the alternative education programs grew to meet the various needs of individual students and families from grades 1-12, district staff proposed merging Creekside High School with Tenaja Canyon Academy. The Board of Education approved the merger and renaming of the alternative education program to Murrieta Canyon Academy.

ENROLLMENT

Due to the type of curriculum offered at Murrieta Canyon Academy, the enrollment is not bounded by a specific area and is open to students across the District. The campus can manage enrollment by acceptance. Current enrollment is 287. Campus capacity will remain relatively constant until and unless additional classrooms and facilities are made available.

FACILITIES

The Campus is comprised entirely of portable buildings. Although projections for this specialized school are difficult, the programs could accept additional students if space and facilities were available. Science and Art Spaces are inadequate. Student Support Services are a higher percentage of the campus area than at other district schools. In all instances these services are provided in ad-hoc spaces and offices that do not provide adequately for staff needs and lack confidentiality.

RECENT IMPROVEMENTS

UTILIZATION

The Campus is 100% utilized. If more space was available for instruction and support, additional students could and would be accepted. The MC Academy lacks basic facilities common to most campuses, notably Food Service.

The District is in planning stages for a new facility to replace the existing relocatable classrooms. The new 23 CR facility will include, general instruction classrooms, CTE classrooms, Student focused Multi-purpose space, Administration,, Counseling and Food Service. The location of the existing campus will be returned as improved fields to Thompson Middle School and expanded parking.

FUNDING SOURCES

The passage of Prop 51 by California voters in November 2016 allows the state to sell \$9 billion of general obligation bonds for public school and community college facilities.

For K-12 School Facilities, the \$7 billion is designated for four types of projects:

- \$3b for new construction,
- \$3b for modernization,
- \$500m for career technical education facilities (funds are exhausted, and the program is closed), and
- \$500m for charter school facilities. (funds are exhausted, and the program is closed)

Prop 51 and other SFP bond funds for New Construction have been exhausted as well, however the State is retaining a list of new construction projects since September 2018 currently amounting to \$163,076,068* that will move to a workload list and reviewed in date order for processing.

STATUS OF FUNDS (AS OF October 31, 2018)

*As of September 12, 2018, the Office of Public School Construction has received requests for new construction projects that exceed the available bond authority, and any applications received on or after this date will be placed on the Applications Beyond Bond Authority List. Funds for new construction will be provided out of the next successful state-wide school bond or as funds are returned to the State after projects are audited.

**CASH and CSBA have been advocating for the new Governor to respect the will of the voters and release the funding from Prop 51 in a timely manner. In the past 2 state budgets combined, only 11 percent of the promised Prop 51 money has been made available to school districts leaving the districts unable to address pressing facility needs. With a backlog of over \$4.6 billion, many of the schools in the queue have been waiting over 5 years to put shovels in the ground or to be reimbursed for past projects so that new ones can begin.

March 2020 Bond

The CASH organization is partnering with Legislative staff to write a bill to place a bond on the March 2020 ballot. A placeholder vehicle may be introduced as early as December 2018, with additional content to be developed and negotiated over early 2019. CASH is working to expand their coalition of supporters and lay the groundwork with key policy makers and staff. They plan to move a bond bill through the Legislature rather than use the initiative process to collect signatures to place a bond on the ballot.

What this means to Murrieta Valley USD

Career-Tech: The Career Technical Education Facilities Program provided funding to qualifying school districts for the construction of new facilities, modernization or reconfiguration of existing facilities, and equipment to integrate Career Technical Education programs into comprehensive high schools. Our District was in the construction document phase of work on the Vista Murrieta HS project. We determined more funding was available through the new construction grant program (\$5.7million vs. \$3m), so we did not submit for CTEC Prop 51 funds. This was a highly competitive program with priority funding. Additionally, more applications were requested than funds were available. We are confident we made the right decision.

New Construction: Eligibility for the Murrieta Valley USD has been calculated to 343 classrooms of eligibility. The New Construction program provides state funds on a 50/50 state and local sharing basis for eligible projects that add capacity to a school district. Adding capacity to a school district can include the construction of a new school, or the addition of classrooms to an existing school. New Construction Eligibility as well as CDE and DSA approval are required to access Prop 51 funds.

The first project to obtain Prop 51 New Construction funds will be the CTEC addition at VMHS. The District has applied for 13 classrooms (351 pupil grants) for a state share of \$5.7million and sits on page 6 of 11 for projects waiting to be reviewed and apportioned.

Modernization: The Modernization program provides state funds on a 60/40 state and local sharing basis for eligible projects have students housed in over age classrooms. Modernization Eligibility for the Murrieta Valley USD has been calculated for 10 campuses with a State share of \$42 million and a minimum district share of \$28 million. Modernization Eligibility as well as CDE and DSA approval are required to access Prop 51 funds for projects that have students housed in overage facilities.

Full-Day Kindergarten Facilities Grant Program

In June 2018, AB 1808 was approved by the Governor to apportion \$100,000,000 statewide to provide one-time grants to school districts to construct new facilities or retrofit existing facilities for the purpose of providing full-day kindergarten classrooms. There are 2 filing rounds - \$37.5million and \$60million. OPSC determined the applications received will exceed the funds available, so preference points (80 in total) have been developed. Forty points will be provided to financial hardship districts (MVUSD does not qualify) and up to forty points will be provided based on the percentage of low income pupils district-wide (MVUSD wont generate enough points to qualify).

MVUSD NEW CONSTRUCTION ELIGIBILITY - 2019

The District currently has Eligibility for both Modernization funds and New Construction. New Construction Eligibility reflects District -wide need whereas Modernization Eligibility is determined separately for each campus. Under the current State Funding Program, the following reflects what the District is eligible for:

IMPLEMENTATION

IMPLEMENTATION

Each of the scopes of work identified for each of the Districts' campuses are based on need as projected for the 2027/2028 Enrollment. Precisely when between now and 2028 each of the Campus plans will be required will vary. The District will continuously evaluate campus conditions and enrollments to gauge when the additional facilities or improvements are needed.

PRIORITIZATION & SCHEDULING

Often a prioritization of projects is required to assess severity of need, funding availability and community or other commitments. The District identifies the prioritized improvements by engaging in design for the improvements in anticipation of future state and local funds.

The District has forwarded design efforts on the following (alphabetical) campuses for major improvements:

Cole Canyon Elementary School Murrieta Elementary School Shivela Middle School Thompson Middle School Murrieta Mesa High School

The District will continue to review all factors in deciding which projects to construct initially and which may have to wait until additional funding can be secured.

MARKET ESCALATION

Depending on the calendar year the District chooses to implement any of the design solutions identified will have a large impact on the overall cost of the project. The cost evaluations herein are intended to reflect current market conditions. A factor needs to be applied to increase the estimates from current market conditions to an anticipation of conditions at the scheduled time of bid. This anticipated inflation over time is referred to as Escalation. Current opinions for escalation over the short term are between 3-5% annually.

Each Campus' Cost Analysis includes a line item for Escalation over time although no values have been included at present. Once the District has decided on a prioritization of projects and an identification of when in time each project will begin, the cost analyses must be adjusted for escalation due to inflation and market conditions. Market conditions vary and escalation estimates should be evaluated yearly to better assess local economic realities.

It is recommended that a contingency factor be included in the Districts budgeting in anticipation of changing economic and market conditions including unforeseen circumstances, market conditions in excess of escalation factor, interim housing (if necessary), etc.


