MVUSD engages community members on a regular basis to obtain feedback and input regarding district/school operations and procedures with a focus on student learning and success.

MVUSD held the district’s Partnership for Thriving Students and Families (PTSF) meeting on September 8<sup>th</sup>. This group is the umbrella organization with a leader/representative from each of the district’s advisory groups. During the meeting, we reviewed the ESSER III grant specifics as well as a presentation for them to share with their advisory group to obtain feedback for the grant plan.

The presentation included the specifics of the ESSER III and ELOG grants, proposed areas to support, and a slide with a Padlet link for community members to provide input. We included 3 questions for community members to provide feedback:

1. What do you see as the greatest student needs this school year?
2. What feedback do you have about the areas we have identified for the grants?
3. Do you have any additional items that support student learning to consider as we develop the grant plans?

Each of the advisory group leaders/representatives shared the prepared presentation with their group to obtain feedback utilizing Padlet. The following groups met to obtain feedback:

The advisory group feedback was included in the discussion and development of the ESSER III Plan. The following themes became apparent after the advisory group meetings:

- Mental health and counseling services and supports
- Behavioral services and supports
- Access to intervention and tutoring
- Access technology devices and programs

These same themes emerged from previous community member feedback for our Local Control and Accountability Plan (LCAP) and Expanded Learning Opportunities Grant (ELOG) Plan. A similar process for community member input was used to develop these plans. The community member input was more authentic and our advisory group participants appreciated the opportunity to collaborate and share.

MVUSD does not have active advisory groups specifically representing civil rights groups, tribes, or advocates at this time. These specific community members may be involved in other advisory groups.

Many of the themes from advisory group feedback align directly with our planned use of funds for the ESSER III, ELOG, and 21-22 LCAP plans. These themes include counseling services, after school and Saturday tutoring (include EL and Special Education), transportation for students who attend tutoring, intervention K-12, credit recovery, summer school, bilingual aide support, and mental health/behavioral supports and services.

Specifically, the plan includes expanded intervention K-12, tutoring services (including transportation), mental health/behavioral services and supports, and educational technology. Our MVUSD team has reviewed specific ideas provided by community members to integrate as we develop and implement the ESSER III plan. Our community members validated our assessment of district needs to be addressed in the plan.

The ESSER III grant provided the additional funds for MVUSD to hire additional K-5 teachers to further lower class sizes and eliminate grade combination classes, expand counseling services, increase after school and Saturday tutoring to include EL and Special Education students, provide transportation for students for after school and Saturday tutoring, increase interventions for students K-12, provide additional credit recovery classes, increase summer school offerings K-12, increase bilingual aide hours, increase contracted mental health/behavioral supports and services, and provide educational technology to meet the varying programs offered for students and families (Virtual and Independent Study).

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

    - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
    - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Any activity authorized by the Adult Education and Family Literacy Act;
  - Any activity authorized by the Carl D. Perkins Career and Technical Education Act of 2006;
  - Coordination of preparedness and response efforts of LEAs with State, local, Tribal, and territorial public health departments, and other relevant agencies, to improve coordinated responses among such entities to prevent, prepare for, and respond to COVID-19;
  - Activities to address the unique needs of low-income students, students with disabilities, English learners, racial and ethnic minorities, homeless students, and foster youth, including how outreach and service delivery will meet the needs of each population;
  - Developing and implementing procedures and systems to improve the preparedness and response efforts of LEAs;

- Training and professional development for staff of the LEA on sanitation and minimizing the spread of infectious diseases;
- Purchasing supplies to sanitize and clean the facilities of an LEA, including buildings operated by such agency;
- Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;
- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

**Note:** A definition of “underserved students” is provided in the Community Engagement section of the instructions.

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;

- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
