## **School Description**

E. Hale Curran Elementary School is a STEM focused school serving students in Preschool through 5th grade. STEM - science, technology, engineering and math education, is integrated into the regular curriculum as well as through project-based instruction. We are committed to creating an environment where children are excited about learning and approach learning with a growth mindset. Through our STEM focus, we are working on developing and fostering 21st century learning skills. We believe that students must develop creativity, curiosity, collaboration, communication and critical thinking skills in order to be college and career ready. We are a community of learners where the needs of children come first. Our goal of every student achieving at high levels drives our decision making and instructional planning. Through our focus on student learning and high expectations for all students, we are preparing our students for success.

We invite parents and community members to join us as we focus on student learning and set high expectations for our students that will help them be successful. Together we can prepare today's students to succeed in tomorrow's world.

## **Highlights & Achievements:**

- Our PTA has held fundraisers through a virtual Scholastic Book fair and will be doing a virtual Strong-A-Thon with a focus pledges to toward reading and exercise minutes.
- Our PTA has also approved the funds for a mural to be painted in our multipurpose room to enhance our climate and culture.
- Each Friday we do a Virtual Friday Flag. This gives us a venue to promote initiatives. In October we focused on attendance with a message of Here, Every day, Ready, and On Time (Hero). In November we focused on things to be thankful for, and December is kindness month. Each Monday has been accompanied with a theme and spirit dress up days. Messages at the virtual flag are delivered by the school resource officer, the principal, assistant principal, and counselor. Teachers have led the cheer, told chokes, and take pictures of students to share each Friday during our Friday Flag. Students will do the pledge, tell jokes, and share pictures of themselves dressed up for spirit days.
- Dress up spirit days we have had include, Dress Like a Hero, Crazy Hair Day, Hat Day, Pajama Day, Bring your Pet to Virtual School Day.
- Our Cougars in the news is shown every Monday. We have our own student News team
  that keeps our staff and students up to date with school happenings. The team
  interviews teachers and other adults at Curran.
- We have an attendance team that meets weekly to discuss activities to get students engaged. The attendance team also discusses individual students. From these meetings our counselor will reach out to families to help support their child. We have also opened one cohort for students with attendance issues.
- We have five cohorts up and running. They include a k-5 SDC cohort, 3-5 SDC cohort, k-2 SDC cohort, preschool SDC cohort, and a cohort for students needing support with attendance and engagement.
- Our counselor meets with students to do counseling sessions with them. Students who
  participated are identified based on previous year supports, teacher input, attendance
  data, or parent request.
- To support families during the virtual learning we have checked out over 400 devices.
   We had an aide whose primary responsibility was to assist parents and students with technology problems. Our office staff has also been trained in troubleshooting technology issues to assist families.

- For families with wi-fi connectivity issues we order ethernet cables from the district support center and hold them in the office for families to pick up.
- At the beginning of the year our leadership team decided to purchase school supplies for all students so they would have what was needed in the virtual classroom. We have held multiple curriculum and material pick-ups.
- Leadership decided to purchase Nearpod, Flocabulary, and BrainPOP as supports for teachers in the virtual environment. These programs help greatly with providing students with asynchronous learning and lessons led by the teacher.

## School Facility Conditions and Planned Improvements (Most Recent Year)

E. Hale Curran Elementary School opened in 1989. The school has 34 classrooms, a multipurpose room, several computer labs, a library, cafeteria, administrative offices, a staff lounge, and four play areas—one for preschool students, one for kindergarten students, one for SEED and one for students in grades one through five. Childcare facilities for all grades are located on campus in a separate building and play area. We have ample space for the number of students enrolled at the school.

Upkeep, maintenance, and cleaning of district schools are provided by the district. Schools and rest rooms are cleaned daily, and the administration works with the custodial staff to ensure a clean and safe school. Any graffiti or vandalism is removed or repaired as soon as it is discovered. District maintenance staff members regularly pick up litter and maintain landscaping on a regular weekly schedule.

Corrective and preventative maintenance are scheduled on a routine basis to keep the school in good repair and working order. Recently the school received a new, state of the art, fire alarm system as well as new roof work on several buildings. Our blacktop areas were also recently resurfaced. Work order requests, assigned through a computerized work order system, ensure that emergency repairs are given the highest priority.

## Opportunities for Parental Involvement (School Year 2020-21)

Curran invites parents and students to attend virtual events such as, Back-to-School Night in the fall, Parent-Teacher Conferences in October, and STEM Expo in the spring. In addition, families are invited to participate in Math Night, Engineering Night, and our STEM Expo in March. Parent and community involvement is encouraged through PTA and School Site Council. The PTA is actively involved in Red Ribbon Week, Reflections, School-wide assemblies, book fairs, and other activities to enhance school and community spirit. The School Site Council, composed of parents and staff members, meets 3 - 4 times/year to make informed decisions regarding the school including a review of the School Plan for Student Achievement.

MVUSD continues to be deliberate in its efforts to engage parents of diverse backgrounds and to obtain feedback regarding each student's academic journey, emotional supports and engagement within their school site. MVUSD parents are invaluable partners and each parent group is comprised of dedicated parents who are steadfast in promoting strategic efforts to support student learning and college/career readiness. Group opportunities for parents are; Action Team Partnership (ATP), African American Parent Advisory Council (AAPAC), Latino Parent Advisory Council (LPAC), District English Learner Advisory Council (DELAC) and Special Education Parent Advisory Council (SEPAC). Additionally, our school sites offer a variety student and parent groups including: School Site Council (SSC), English Learner Advisory Council (ELAC), principal/student advisory groups, PTA/PTSA/PTO and staff leadership teams.

#### School Safety Plan (School Year 2020-2021)

School safety is a high priority at E.Hale Curran Elementary. Administrators, teachers, and aides monitor the campus, supervise the students, and ensure a safe learning environment. School resource officers are available to respond to the school if assistance is needed. E.Hale Curran Elementary is a closed campus that is fully fenced. Visitors and volunteers must report to the office for permission to be on campus. We utilize the Raptor Visitor Management System to monitor parent volunteers on campus to ensure all volunteers are screened against California's Megan's Law database as well as all 50 states' sex offender databases. Video surveillance cameras across our campus are a deterrent to trespassers, vandalism, and other illegal activities. They also help administrators with discipline issues and help with the investigation of any crimes that occur on campus during the school day or after school hours, making our school safer and more secure.

The district holds monthly virtual safety meetings, and our School Site Council (SSC) works on our Safety Plan throughout the year. We adopted a Comprehensive School Safety Plan that we review annually; our last review took place in January 2020. The plan is presented to all staff and parents, and we hold numerous student assemblies to address safety issues.

The district has a strictly enforced anti-discrimination policy that prohibits harassment of students or staff based on race, gender, disability, religion, or sexual orientation.

In a traditional school year, all MVUSD schools prepare for emergencies, through regular evacuation drills including the statewide Great Shakeout. In addition, our school has an Emergency and Disaster Preparedness Plan that aligns with the federal NIMS emergency system. The plan specifies procedures for dealing with fire, flood, earthquakes, lock downs, hazardous materials, disaster recovery organization, and student accountability following a disaster. In the event of an emergency or urgent situation, our school uses a computerized calling system through Aeries Communication, to immediately notify all families of an emergency via email, phone call, text and app alerts.

During the 2019-2020 school year, Murrieta Valley USD continued to provide professional development to support teachers and staff in delivering high quality learning for our students. During the spring closure for schools, district employees were offered a week-long professional development series focused on virtual learning skills and resources. All trainings centered around engagement strategies and 21st Century digital skills necessary to instruct students virtually. In addition, ongoing asynchronous and weekly live trainings were offered throughout the year to all staff.

As MVUSD prepared to strengthen teachers' online instructional pedagogy for the 2020-21 school year, teachers and administrators were provided access to the Leading-Edge Certification program, which is a 30-hour online course in robust virtual learning skills and strategies. During the summer, MVUSD provided opportunities for teachers to prepare for the upcoming school year focused on providing quality virtual instruction and mitigating learning loss for students in a virtual environment. Additionally, the student calendar was adjusted to move two professional development days to the beginning of the school year for intensive training on the implementation of our new learning management system (Canvas). All teachers take part in monthly virtual staff meetings that are used for training, community building, and communication.

New teachers are provided support and the opportunity to clear their credential through the district's Teacher Induction Program, which takes them through a rigorous and reflective learning process with the help of a mentor teacher. All teachers who are new to the district also receive three days of training to learn about key focus areas, as well as district expectations and procedures.

## **Types of Services Funded**

The district provides a wide array of programs to meet the needs of our diverse student body. This includes programs to identify and support students and their families through times of crisis and stress. A health technician, nurse, and psychologist are also available to meet with students and their families virtually and by appointment in-person.

The district provides a full-time counselor to our school to support social-emotional and academic success. Counselors teach guidance lessons and facilitate small groups on social skills, anger management, grief, and loss and provide support to military-connected students. They also provide individual responsive services, interventions, and referrals on an as-needed basis. During distance learning, our counselors have provided virtual "Counseling Corner", videos and office hours to assist students, families, and staff in need.

24/7 tutoring was implemented through Paper.co for all students in grades 4-12. This online 24/7 service is free to students, in lieu of in-person homework clubs, and before/after-school tutoring programs. Extended learning opportunities during the summer break continues to provide additional support for students who need assistance with basic curriculum.
