# **School Description**

Lisa J. Mails Elementary School school serves students in kindergarten through fifth grade. We have a unique focus on arts education and a strong emphasis on academic achievement. Students receive curricula and instruction similar to that found in the other schools in our district. This academic framework is enhanced by the arts focus, which includes music, theater, visual art, and dance as well as integrating the arts to support learning in the regular curriculum. The school focus is also brought to life through arts-related assemblies, field trips, and school-wide events, such as our Student Showcases, Artist-in-Residencies, and our annual Artist Fair. At Lisa J. Mails Elementary School, we have a mission of HEART: Harmony, Empathy, Achievement, Reflection, and Transformation. This mission is taught to each student and supported through school-wide recognition and daily character development.

Lisa J. Mails has an active parent community. Our PTA is integral to our mission, and parent participation occurs at many levels, supporting academics, our arts focus, and community-building events. We are a school in which, truly, parents and teachers come together to partner on behalf of the students we are serving!

#### **Highlights & Achievements:**

- Lisa J. Mails Elementary has continued to set attendance and engagement as a priority during the 20/21 school year. While in a virtual instructional model, LJM continues to maintain one of the lowest chronic absenteeism rates in the school district at 2.58% in December 2020.
- Lisa J. Mails has continued to engage students in a variety of ways during virtual teaching and learning. Teachers and staff continue to have spirit and theme-based days such as Kindness Challenge, Mindset Monday, Think Outside the Box Thursday, an Ornament Contest, a Lego Challenge, Virtual Soaring Spirit Assemblies, dress-up days, and much more.
- Lisa J. Mails continues to maintain an arts focus during virtual learning. Live open Art
  demonstrations are conducted every Wednesday providing students a rich opportunity
  to complete an art project with peers from across campus. Teachers and staff continue
  to plan and prepare art supplies as part of the bi-weekly materials pick-up, which allows
  for virtual classroom art activities. In the 3rd 5th grade Panorama student survey,
  students commented that art was one thing they are enjoying most about school this
  year.
- Students continue to show academic growth as evident on the reading and math iReady diagnostic administered in August and again in December 2020. In the area of reading, students in Tier 1 (on track to meet grade-level standards) moved from 45% in August to 59% in December in grades 2nd 5th. In the area of math, students in Tier 1 moved from 23% in August to 42% in December in grades 2nd 5th.
- The Lisa J. Mails counseling services continue to thrive in the virtual environment. Students can easily navigate requesting a meeting with the school counselor and socialemotional learning lessons continue to be taught in classrooms. In addition, the school counselor utilizes peer leaders in the Kindness Crew to initiate school-wide campaigns such as singing for senior citizens and military veteran appreciation.
- At Lisa J. Mails, small in-person specialized cohorts began in November 2020. Currently, every SDC and RSP teacher provides an in-person cohort, to include Pre-K SDC. In addition, a daily in-person cohort was established for students that had minimal or no connectivity and engagement at home with virtual school.

• The Leadership Team at Lisa J. Mails has taken the 20/21 school year as an opportunity to reflect on our school's mission statement and core values for the purpose of redeveloping, engaging, and igniting the why behind what we do as a staff community.

Lisa J. Mails Elementary School opened in August, 2007 as the eleventh elementary school in the Murrieta Valley Unified School District. The campus has 39 classrooms, a multipurpose room with a kitchen, 3 computer labs, a library, an outdoor eating area, an amphitheater, administrative offices, a health office, teacher workrooms throughout the campus and two play areas, one for kindergarten students and one designated for students in grades 1-5.

The district's Facilities and Operational Services Departments provide upkeep, maintenance, and cleaning of district schools. Classrooms and restrooms are cleaned daily, and the principal works with the custodial staff to ensure a clean and safe school. The district's maintenance staff picks up litter and maintains landscaping using a regular, weekly schedule.

# Opportunities for Parental Involvement (School Year 2020-21)

At LJM, administration works hard to involve parents in their child's education. Parents are encouraged to remain active in our school virtually. Because of the pandemic, many activities were held virtually such as; Back-to-School Night, Open House, and parent-teacher conferences in October. Last year, our school continued to run the Watch DOGS (Dads of Great Students) program to support school safety and promote parent involvement. The Watch DOGS program involves fathers and other adult male relatives who volunteer for one day to help supervise students, provide classroom academic support, and participate in many other activities during the school day. This program has been well-received and has brought a positive male presence to our campus daily.

Lastly, MVUSD continues to be deliberate in its efforts to engage parents of diverse backgrounds and to obtain feedback regarding each student's academic journey, emotional supports and engagement within their school site. MVUSD parents are invaluable partners and each parent group is comprised of dedicated parents who are steadfast in promoting strategic efforts to support student learning and college/career readiness. Group opportunities for parents are; Action Team Partnership (ATP), African American Parent Advisory Council (AAPAC), Latino Parent Advisory Council (LPAC), District English Learner Advisory Council (DELAC) and Special Education Parent Advisory Council (SEPAC). Additionally, our school sites offer a variety of student and parent groups including: School Site Council (SSC), English Learner Advisory Council (ELAC), principal/student advisory groups, PTA/PTSA/PTO and staff leadership teams.

#### School Safety Plan (School Year 2020-2021)

School safety is a high priority at Lisa J. Mails Elementary. Administrators, teachers, and aides monitor the campus, supervise the students, and ensure a safe learning environment. School resource officers are available to respond to the school if assistance is needed. Lisa J. Mails Elementary is a closed campus that is fully fenced. Visitors and volunteers must report to the office for permission to be on campus. We utilize the Raptor Visitor Management System to monitor parent volunteers on campus to ensure all volunteers are screened against California's Megan's Law database as well as all 50 states' sex offender databases. Video surveillance cameras across our campus are a deterrent to trespassers, vandalism, and other illegal activities. They also help administrators with discipline issues and help with the investigation of any crimes that occur on campus during the school day or after school hours, making our school safer and more secure.

The district holds monthly virtual safety meetings, and our School Site Council (SSC) works on our Safety Plan throughout the year. We adopted a Comprehensive School Safety Plan that we review annually; our last review took place in January 2020. The plan is presented to all staff and parents, and we hold numerous student assemblies to address safety issues.

The district has a strictly enforced anti-discrimination policy that prohibits harassment of students or staff based on race, gender, disability, religion, or sexual orientation.

In a traditional school year, all MVUSD schools prepare for emergencies, through regular evacuation drills including the statewide Great Shakeout. In addition, our school has an Emergency and Disaster Preparedness Plan that aligns with the federal NIMS emergency system. The plan specifies procedures for dealing with fire, flood, earthquakes, lock downs, hazardous materials, disaster recovery organization, and student accountability following a disaster. In the event of an emergency or urgent situation, our school uses a computerized calling system through Aeries Communication, to immediately notify all families of an emergency via email, phone call, text and app alerts.

During the 2019-2020 school year, Murrieta Valley USD continued to provide professional development to support teachers and staff in delivering high quality learning for our students. During the spring closure for schools, district employees were offered a week-long professional development series focused on virtual learning skills and resources. All trainings centered around engagement strategies and 21st Century digital skills necessary to instruct students virtually. In addition, ongoing asynchronous and weekly live trainings were offered throughout the year to all staff.

As MVUSD prepared to strengthen teachers' online instructional pedagogy for the 2020-21 school year, teachers and administrators were provided access to the Leading-Edge Certification program, which is a 30-hour online course in robust virtual learning skills and strategies. During the summer, MVUSD provided opportunities for teachers to prepare for the upcoming school year focused on providing quality virtual instruction and mitigating learning loss for students in a virtual environment. Additionally, the student calendar was adjusted to move two professional development days to the beginning of the school year for intensive training on the implementation of our new learning management system (Canvas). All teachers take part in monthly virtual staff meetings that are used for training, community building, and communication.

New teachers are provided support and the opportunity to clear their credential through the district's Teacher Induction Program, which takes them through a rigorous and reflective learning process with the help of a mentor teacher. All teachers who are new to the district also receive three days of training to learn about key focus areas, as well as district expectations and procedures.

# **Types of Services Funded**

The district provides a wide array of programs to meet the needs of our diverse student body. This includes programs to identify and support students and their families through times of crisis and stress. A health technician, nurse, and psychologist are also available to meet with students and their families virtually and by appointment in-person.

The district provides a full-time counselor to our school to support social-emotional and academic success. Counselors teach guidance lessons and facilitate small groups on social skills, anger management, grief, and loss and provide support to military-connected students. They also provide individual responsive services, interventions, and referrals on an as-needed basis. During distance learning, our counselors have provided virtual "Counseling Corner", videos and office hours to assist students, families, and staff in need.

24/7 tutoring was implemented through Paper.co for all students in grades 4-12. This online 24/7 service is free to students, in lieu of in-person homework clubs, and before/after-school tutoring programs. Extended learning opportunities during the summer break continues to provide additional support for students who need assistance with basic curriculum.
