School Description

Shivela Middle School, named a California Gold Ribbon School, serves students in grades six through eight. Our mission is to work in partnership with parents, teachers, administration, and the community to prepare our students for the future by developing the lifelong commitment to learning that is necessary for their success in our global society. There is a strong emphasis on campus toward student learning. We have an engaging culture in which students are encouraged to get involved. Shivela's core tenants are to live the Panther Life (Learning, Integrity, Friendship and Excellence). Shivela Middle School is a STEM (Science, Technology, Engineering, and Math) school and we continue to increase our offerings of STEM related electives. We offer many acceleration and intervention classes throughout the school day to support student learning. Our teachers spend a great deal of time collaborating and analyzing data to identify key practices to support student learning.

Shivela Middle School was approved as a Common Sense Digital Citizenship Certified School, an honor that recognizes our efforts in teaching digital literacy and citizenship to our students and engaging the entire school community in this important discussion.

Highlights & Achievements:

- Shivela's AVID program (Advancement Via Individual Determination) continues to grow.
- We have recently offered zero period courses to increase student learning opportunities. Courses include Advanced Mathematics, Computer Coding, a 6th grade STEM course, Physical Education, Athletic PE, and Fitness PE.
- Shivela is a STEM school. Teachers are trained and STEM electives include a 6th grade STEM course, one period of Computer Coding, six periods of a computer-based class title "Transitions", six periods of Robotics and six periods of Digital Photography.
- Student leadership opportunities include ASB, Senate, Video Production, WEB, and Yearbook. Eighteen percent of the students at Shivela are involved in a leadership class.
- There is a strong emphasis on the arts with award-winning programs in Band, Choir and Strings.

Shivela Middle School opened in 1990. The school has 58 classrooms, a multipurpose room, two computer labs, a library, a kitchen, a covered lunch area, library, cafeteria, administrative offices, a gymnasium, athletic fields, and a track. We have ample space for the number of students enrolled at the school. The district provides upkeep, maintenance, and cleaning of district schools. Schools and rest rooms are cleaned daily, and the principal works with the custodial staff to ensure a clean and safe school. District maintenance staff maintains landscaping on a regular weekly schedule.

Corrective and preventative maintenance is scheduled on a routine basis to keep the school in good repair and working order. Work order requests assigned through a computerized work order system ensure that emergency repairs are given the highest priority.

Opportunities for Parental Involvement (School Year 2020-21)

Parent and community involvement are encouraged through the Parent Teacher Student Association (PTSA), Watch DOGs (Dads of Great Students), School Climate Committees and the School Site Council (SSC). The PTSA is actively involved in virtual activities and contests to enhance school and community spirit, and reward and incentive programs. The SSC, which includes three parents, three students, and three staff members, helps us provide a quality education program for all of our students. Shively has also implemented a school specific Latino Parent Advisory Council (LCAP).

Lastly, MVUSD continues to be deliberate in its efforts to engage parents of diverse backgrounds and to obtain feedback regarding each student's academic journey, emotional supports and engagement within their school site. MVUSD parents are invaluable partners and each parent group is comprised of dedicated parents who are steadfast in promoting strategic efforts to support student learning and college/career readiness. Group opportunities for parents are; Action Team Partnership (ATP), African American Parent Advisory Council (AAPAC), Latino Parent Advisory Council (LPAC), District English Learner Advisory Council (DELAC) and Special Education Parent Advisory Council (SEPAC). Additionally, our school sites offer a variety student and parent groups including: School Site Council (SSC), English Learner Advisory Council (ELAC), principal/student advisory groups, PTA/PTSA/PTO and staff leadership teams.

School Safety Plan (School Year 2020-2021)

School safety is a high priority at our school. Shivela is a closed campus that is fully fenced. Visitors must go through the school office for permission to be on campus. We utilize the Raptor Visitor Management System to screen parent volunteers before they enter to ensure all volunteers are screened against California's Megan's Law database as well as all 50 states' sex offender databases. Campus supervisors, administrators, and counselors are on campus daily to monitor the campus, supervise the students, and ensure a safe learning environment. Our computerized calling system, Aeries Communication, is used to immediately call, email, text, and app alert all families in an emergency. A School Resource Officer is available as needed to assist during the school day or after school hours, making our school safer and more secure. Trained canines provide unannounced canine searches of the campus for drugs, alcohol, and weapons. Video surveillance cameras across our campus are a deterrent to trespassers, vandalism, and other illegal activities.

The district holds monthly virtual safety meetings. We have adopted a Comprehensive School Safety Plan is revised each year and reviewed by the School Site Council, staff and parents. We hold student assemblies to address safety issues at the start of the school year and again with eighth grade during second semester. To prepare for emergencies, we conduct evacuation drills regularly throughout the school year.

The school has an Emergency and Disaster Preparedness Plan which specifies procedures for dealing with fire, flood, earthquakes, lockdowns, hazardous materials, disaster recovery organization, and student accountability following a disaster, and it aligns with the federal NIMS emergency system.

The district has a strictly enforced anti-discrimination policy that prohibits harassment of students or staff based on race, gender, disability, religion, or sexual orientation.

During the 2019-2020 school year, Murrieta Valley USD continued to provide professional development to support teachers and staff in delivering high quality learning for our students. During the spring closure for schools, district employees were offered a week-long professional development series focused on virtual learning skills and resources. All trainings centered around engagement strategies and 21st Century digital skills necessary to instruct students virtually. In addition, ongoing asynchronous and weekly live trainings were offered throughout the year to all staff.

As MVUSD prepared to strengthen teachers' online instructional pedagogy for the 2020-21 school year, teachers and administrators were provided access to the Leading-Edge Certification program, which is a 30-hour online course in robust virtual learning skills and strategies. During the summer, MVUSD provided opportunities for teachers to prepare for the upcoming school year focused on providing quality virtual instruction and mitigating learning loss for students in a virtual environment. Additionally, the student calendar was adjusted to move two professional development days to the beginning of the school year for intensive training on the implementation of our new learning management system (Canvas). All teachers take part in monthly virtual staff meetings that are used for training, community building, and communication.

New teachers are provided support and the opportunity to clear their credential through the district's Teacher Induction Program, which takes them through a rigorous and reflective learning process with the help of a mentor teacher. All teachers who are new to the district also receive three days of training to learn about key focus areas, as well as district expectations and procedures.

Types of Services Funded

The district provides a wide array of programs to meet the needs of our diverse student body. This includes programs to identify and support students and their families through times of crisis and stress. A health technician, nurse, and psychologist are also available to meet with students and their families virtually and by appointment in-person.

The district provides a full-time counselor to our school to support social-emotional and academic success. Counselors teach guidance lessons and facilitate small groups on social skills, anger management, grief, and loss and provide support to military-connected students. They also provide individual responsive services, interventions, and referrals on an as-needed basis. During distance learning, our counselors have provided virtual "Counseling Corner", videos and office hours to assist students, families, and staff in need.

24/7 tutoring was implemented through Paper.co for all students in grades 4-12. This online 24/7 service is free to students, in lieu of in-person homework clubs, and before/after-school tutoring programs. Extended learning opportunities during the summer break continues to provide additional support for students who need assistance with basic curriculum.

DataQuest

DataQuest is an online data tool located on the CDE DataQuest web page at <https://dq.cde.ca.gov/dataquest/> that contains additional information about this school and comparisons of the school to the district and the county. Specifically, DataQuest is a dynamic system that provides reports for accountability (e.g., test data, enrollment, high school graduates, dropouts, course enrollments, staffing, and data regarding English learners).
