We continue to provide a standards-based education program while implementing the academic standards that will prepare children to work with others in the 21st century. Highlights & Achievements:

- Our school took part in the third year of the California Assessment of Student Performance and Progress (CASSPP) assessments. 47% of students in grades 3 – 5 met or exceeded standards in English Language arts, and 42% of students in grades 3 – 5 met or exceeded standards in Math.
- We implemented a math-fact fluency program that focuses on students' mastery of basic facts, along with a new concept-based math program.
- For our struggling readers, we instituted an intervention program during the school day to ensure access for all of the students who needed it. This program is developed around the concept of a learning center where all of our resources are available to all students. In the learning center we have trained staff to assist students as well as intervention programs to meet their needs. The intervention programs include READ 180, an intensive supplemental reading program that replaces the basic curriculum and helps accelerate struggling readers; I-Read, a supplemental program provided in addition to the regular reading program to help students meet their grade-level goals; and Systems 44, a program that focuses on the 44 phonemes (sounds) of the English language.
- We promote a well rounded education by providing opportunities for visual and performing arts exposure through 5th grade Band, Ballet Folklorico, Poetry, Hip Hop, & Cultural Dance, 4th grade Visual Arts & Recorders. 3rd Grade cartooning & Hip Hop. 2nd Grade Ballroom Dancing & Intro to Art. 1st grade Intro to Music & Musical Theater. Kindergarten Sing-A-Long and Hip Hop. 3rd - 5th grade choir and K - 5th grade school musicals.

School Facility Conditions and Planned Improvements (Most Recent Year)

Monte Vista Elementary School opened in August of 2003 as the ninth elementary school in Murrieta Unified School District. The campus has 53 classrooms, a multipurpose room, speech and Resource Specialist Program (RSP) rooms, a computer lab, library, cafeteria, administrative offices, staff lounge, and two play areas. One play area is for kindergarten, while the other is designated for students in grades one through five. Childcare facilities for students are located on campus as well as a preschool class. We have ample space for the number of students enrolled at the school.

The district provides upkeep, maintenance, and cleaning services. Schools and rest rooms are cleaned daily, and the principal works with the custodial staff to ensure a clean and safe school. Graffiti is removed as soon as it is discovered. District maintenance staff members pick up litter and maintain landscaping on a regular weekly schedule. Corrective and preventative maintenance is scheduled on a routine basis to keep the school in good repair and working order. Work order requests assigned through a computerized work order system ensure that emergency repairs are given the highest priority.

Opportunities for Parental Involvement (School Year 2017-18)

Parents are welcome at school and the school staff sincerely appreciates their support and participation. Parents are encouraged to volunteer in their child's classroom as well as for the many special activities throughout the year. Parents are invited to attend Back-to-School Night in the fall, Open House in the spring, and parent /teacher conferences in October. Several times each year, the principal invites the parents and other community members in to discuss issues. These are informal gatherings and all interests and views are welcome.

Parent and community involvement are encouraged through PTA and School Site Council (SSC). The PTA is actively involved in Red Ribbon Week, Reflections, assemblies, book fairs, and activities to enhance school and community spirit, as well as reward and incentive programs. The SSC, which includes five parents and five staff members, purchases additional support curriculum materials. Our parent contact representative is our PTA President, Natalie Bull.

School Safety Plan

School safety is a high priority at Monte Vista Elementary. Administrators, teachers, and other staff monitor the campus, supervise the students, and ensure a safe learning environment. School Resource Officers are available to respond to the school if necessary. Our computerized calling system is used to call all families immediately in an emergency. Monte Vista is a closed campus. All gates are locked during the school day. Visitors and volunteers must report to the office for permission to be on campus. We utilize the Raptor Visitor Management System to monitor parent volunteers on campus to ensure all volunteers are screened against California's Megan's Law database as well as all 50 states' sex offender databases.

The district holds monthly safety meetings and our School Site Council works on our Safety Plan throughout the year. We adopted a Comprehensive School Safety Plan, which we review annually; our last review was in January 2018. The plan was presented to all staff and parents, and we hold numerous student assemblies that address safety issues. Video surveillance cameras across our campus are a deterrent to trespassers, vandalism, and other illegal activities. They also help administrators with discipline issues and help in the investigation of any crimes that occur on campus during the school day or after school hours, making our school safer and more secure.

Murrieta Police Department officers teach the DARE curriculum to all fifth graders to give them the skills and confidence necessary to resist the use of alcohol, drugs, and gang involvement. The district has a strictly enforced anti-discrimination policy that prohibits harassment of students or staff based on race, gender, disability, religion, or sexual orientation.

To prepare for emergencies, evacuation drills are conducted regularly throughout the school year, and our school actively participates in the statewide Great Shakeout. After each drill, we assess effectiveness and implement new procedures as needed. In addition, the school has an Emergency and Disaster Preparedness Plan that aligns with the NIMS emergency system. The plan specifies procedures for dealing with fire, flood, earthquakes, lock downs, hazardous materials, disaster recovery organization, and student accountability following a disaster.

Professional Development provided for Teachers

All teachers in the MVUSD school district participate in ongoing professional development as a part of the district's commitment to continuous learning.

New teachers are provided support and the opportunity to clear their credential through the district's Teacher Induction Program, which takes them through a rigorous and reflective learning process with the help of a mentor teacher.

All teachers take part in monthly staff meetings that are used for training, community building, and communication. Regular Early Release and Late Start days provide teachers with time for Professional Learning Communities (PLC's). This learning time designed by teachers and focused on supporting all students in meeting the state standards. Staff development days are held three times throughout the school year. The design of these days may be facilitated by the site or district and involves training on district-wide focus areas. The district also provides training in the new standards to all teachers, both by grade level and by subject. These occur during the school year (release days) or in the summer. Individual schools also fund professional conferences for teachers based on current areas of focus.

The district also provides a foundational training entitled, Elements of Effective Instruction. The program is made up of fourteen modules, including topics such as classroom environments, student engagement, designing instruction, and digital learning experiences along with topics for special education teachers. These modules, along with follow up sessions, are repeated throughout the school year and summer and are available to all teachers.

Staff development is provided in the form of community teams for those teachers taking part in or leading the implementation of intervention programs, such as Read 180/System 44, iRead, and Math 180. These regular meetings provide teachers with a deeper understanding about issues related to the programs and to intervention, as well as a forum for collaboration, reflection, and goal setting.

In the 2016 – 2017 school year, staff development continued to emphasize the transition to the new California state standards, primarily Mathematics and English Language Arts.

Types of Services Funded

The district provides a wide array of programs to meet the needs of our diverse student body. This includes programs to identify and support students and their families through times of crisis and stress. A health technician, nurse, and psychologist are also available to meet with students.

The district provides an elementary counselor to our school approximately two and a half days a week to support academic success. Counselors teach guidance lessons and facilitate small groups on social skills, anger management, grief and loss and provide support to military-connected students. They also provide individual responsive services, interventions and referrals on an as needed basis.

Homework clubs, before- and after school tutoring programs, and extended learning opportunities during the summer break provide additional support for students who need assistance with basic curriculum.

DataQuest

DataQuest is an online data tool located on the CDE DataQuest Web page at <http://dq.cde.ca.gov/dataquest/> that contains additional information about this school and comparisons of the school to the district and the county. Internet Access
