

## Murrieta Valley Unified School District (MVUSD) Student Device Loan Agreement

**Terms of Loan:** The equipment is the sole property of Murrieta Valley Unified School District (MVUSD). It is to be used for school-related work **ONLY**, such as accessing classroom instruction and materials. The equipment is to be returned at the conclusion of the loan period or as requested by district or school staff.

**Equipment Replacement:** The equipment replacement cost varies based on market value of equipment that needs to be replaced at the time of needed replacement. If equipment needs to be replaced, it will be evaluated by the District Technology Team for device evaluation. This may delay the repair process and your student may or may not have temporary equipment during the waiting period based on individual circumstances.

Internet Hotspot	\$60 - \$100

**Parent/ Guardian (and Student) Acceptance of Equipment:** I understand that the equipment listed above will be sent home with my student in good working condition. Upon receipt of the device, I and/or my student will report any physical device issues or problems within 14 days. My student and I are responsible for its care and use. We will report any problems to the district technology group for possible repair. My student and I will return all equipment in good working condition, or I may be responsible for the repair or cost of the replacement pursuant to Board Policy 6161.2. All content, including downloads, browser history, and hard drive can be reviewed at any time by district staff and contents must be entirely school related. I understand that my student may be without equipment while it is being repaired.

**Lost / Stolen Equipment:** If the above equipment is stolen, I will file a police report and notify school site where the device was distributed within 7 days. I will be responsible for the replacement cost of the equipment if it is lost or stolen.

**Damage of Equipment:** If the above equipment is willfully damaged, I shall be responsible for **ANY and ALL** repair costs not to exceed the value of replacement costs pursuant to Board Policy 6161.2.

**Indemnity:** Student/Parent/Guardian agrees to indemnify and hold the internet provider and/or the Murrieta Valley Unified School District harmless against any claim, actions, or demands relating to or arising out of any content or software displayed, distributed or otherwise disseminated in any way connected to or through the MVUSD Student Device Loan Program amidst the COVID-19 coronavirus outbreak, including without limitation any malicious or unlawful act affecting any computer, network equipment, or Internet service. MVUSD will not be held responsible for any wrongdoing that your child does with the assigned computer. The Parent/ Guardian/ Student will take full responsibility for any wrongdoing involving the use of the district's equipment.

**Limitation of Liability:** In no event shall MVUSD or the Internet provider be liable for indirect, incidental, punitive, or consequential damages (including without limitation, lost profits) arising out of or in relation to this Agreement, including but not limited to, the use of Internet services of the internet provider and/or the use of MVUSD equipment.

**Student Network Violation:** If Students/Parents/Guardians violate the District's Student Acceptable Use Contract and the District's Annual Notification Document while using the equipment listed above, it may be required that the equipment be returned.
