The Superintendent or designee shall enforce precautionary measures to guard against environmental hazards. Students and staff are encouraged to report any unsafe conditions they may observe.

Air Quality

The Board recognizes the importance of air quality and desires to provide adequate ventilation in classrooms and offices.

Pest Management

Structural and landscape pests can pose a significant risk to people and the environment; therefore, pests must be managed to protect the health and safety of students and staff, maintain a productive learning environment, and maintain the integrity of school buildings and grounds. Sanitary measures shall be enforced and buildings and grounds will be regularly cleaned and repaired in order to prevent infestations and minimize the use of pesticides. Low-risk methods will be given first consideration when selecting appropriate pest management techniques which are effective and economically feasible.

Lead Exposure Reduction

The Board recognizes that exposure to lead is especially damaging to young children and that lead may be present in the paint, soil or drinking water at some schools.

The District shall assess whether students are in danger from exposure to lead at our schools and shall take measures to minimize any harmful exposure.
