C.9 Consider Proposal by Community Member to become "Sanctuary School District"

Public comment regarding this agenda item was heard by the following local and surrounding community members:

Donald Gravett, Pastor Scott Scharpen, Dr. Todd Donohoe, John Andrews, Desare Ferraro, Don Dix, Christian Edwards and Hunter Erickson each expressed their views on parental rights and support of the proposal to become a sanctuary school district.

Stephanie Holloway expressed her opinion in opposition of the proposal to become a sanctuary school district and stated that the views in favor do not represent the entire community.

Pastor Tim Thompson was given the opportunity to present his proposal to become a sanctuary school district. He defines sanctuary school district as follows:

"The term 'Sanctuary School District' refers to municipal jurisdictions in the United States of America that limit their cooperation with the state government's effort to impose laws that usurp the authority of parents in their children's lives, or to impose an ideology that is contrary to a family's core values through state-mandated educational policies."

Pastor Thompson further stated sanctuary school district proponents say they want to reduce governmental control over families, and empower parents and legal guardians to exercise their fundamental rights endowed to them by their Creator to determine who gets to speak into their children's lives, and what that content will be. These proponents request to enact district-wide policies ensuring parental rights, including notification to the parent/guardian of children leaving school campus for any medical reason, including the seeking of an abortion, trans-therapy, or any other 'medical' service. They also reject the enforcement of AB329, SB48, or any other law requiring the teaching, approval or encouragement of topics related to comprehensive sexual health.

Pastor Thompson stated that he is asking the Board to be the first school district in the State to declare itself a sanctuary school district for parental rights.

Attorney, Janet Mueller of Dannis Woliver Kelley outlined the legal authority of the School Board as follows:

"The school Board must follow State and Federal laws until a court decides otherwise or until the law is changed through the legislative process. This includes state-mandated curriculum, parent notification and opt out rights. The School Board must abide by its own Board Policies, which implement state/federal law. Policies safeguard and maximize parental rights within legal framework."

She further discussed the implications of the District on becoming a sanctuary school district.
