A.4 Communications

a. Public Comment

Kendell Winters, Jayden Hornbeek, Emilee Hearn, Tom Tokarchik, Kevin Dennis, and Rick Winters each provided public comment requesting reinstatement of Michael Henderson as the Cheer Coach at Murrieta Valley High School. Additionally, 15 written public comments were submitted via Microsoft Forms and/or email to Julie Diaz, Executive Assistant, with the same request.

a. Public Comment (continued)

Laura Burgues, Kayla Lewis, Briana Heinonen, Michelle Lauritzen, Alissa Nazar, Karen Brann, Laura Kingman, and two students each provided public comment in opposition of students being required to wear face coverings in the classroom for the 2021/22 school year. Additionally, seven written comments were submitted.

Markela Parsons spoke in support of the District continuing to use the Canvas learning platform and commented on the importance of clear transparent communications with Murrieta Educators Association.

Chris Shoultz, MEA High School Director, spoke to the importance of data in making decisions within the organization, particularly as it relates to salary schedules.

Derick Petersen commented on Item E.2 Adoption of Resolution No. 20/21-27 Authorizing the Education Protection Account Requirements, requesting clarification on which budget codes the monies would be applied to. Mr. Petersen was referred to Deputy Superintendent, Bill Olien to answer his specific questions.

Three written comments opposing Critical Race Theory teachings were read aloud by staff members.

One written comment in support of C.5 Authorization for Speech Pathologists to be employed under Education Code 44831 for the 2021/22 School Year was read aloud by a staff member.

b. Employee Organizations Communication

Kimberly Binning-Chevlin, President of the Murrieta Educators Association expressed how nice it was to resume in-person meetings without being required to wear a mask. Mrs. Binning-Chevlin remarked that there were twenty-seven MEA retirees at the end of the 2020/21 school year.

Anna Leos, President of the California School Employees Association, Murrieta Chapter #223 reported that classified employees represent approximately one hundred forty-eight job classifications within the District supporting student learning.

c. Superintendent Communication

Superintendent Patrick Kelley stated that community input is welcome and encouraged continued attendance at board meetings from the local community members. Mr. Kelley expressed his frustration with the limits the pandemic has imposed upon education and said he and the Board members have been advocating with state representatives for a return to normal full-time in person instruction without a mask requirement for the 2021/22 school year. Mr. Kelley remarked that regulations are changing daily and are now moving in a less restrictive direction, therefore he is eagerly anticipating the new California Department of Public Health guidance for K-12 schools in the next two weeks. Mr. Kelley reminded the audience that school districts are required to comply with orders issued by the California Department of Public Health.

d. Board Member Communication

Board member Linda Lunn thanked the members of the public for attending the meeting. She said that she has been frustrated that K-12 education has not been addressed and that she and Mrs. Thomasian have both advocated at the state and local levels to get students

back on campus for full time in-person instruction with common sense practical practices for the 2021/22 school year. Mrs. Lunn encouraged the audience members to continue their advocacy efforts for all of the children.

Board member Kris Thomasian said she shared the same sentiment expressed by the public speakers for the return to a normal pre-pandemic school experience. She expressed her gratitude for Mr. Kelley's advocacy efforts with state and public health officials for the return to normalcy for the 2021/22 school year and encouraged all the audience members to join the Board members in those efforts . Mrs. Thomasian reported attending the California School Board Association Delegate Assembly Zoom meetings held May 14 – 16, 2021, where she received updates on education legislation, state budget, full and fair funding proposition and discussed addressing student needs when they return to the classroom. Mrs. Thomasian praised the local businesses that have partnered with MVUSD Adult Transition Program to offer comprehensive opportunities to support students.

Board member Kenneth Dickson said it was wonderful to have members of the public present their comments to the Board. He said this has been a very engaging meeting and asked the audience to continue their advocacy efforts to the state level and reiterated that the School Board has been under the authority of others at the state level with regards to public health mandates.

Board member Oscar Rivas thanked all the members of the public for participating in the meeting and expressing their sentiments about wearing masks in the school setting. Mr. Rivas stated that he is so very grateful to the staff for the shining examples they have been to his children during the 2020/21 school year.

Board member Paul Diffley stated that the audience in attendance are an expression of our community and suggested that the Board explore a resolution to demonstrate their conviction to returning to a normal 2021/22 school year, without masks.
