Unless hereinafter specifically noted or specified otherwise, all work shall confirm to the applicable provisions of the Contract Documents.

BID ADDENDUM NO. 4 DESCRIPTION:

Bid RFI Questions and Responses:

1. Bid RFI 1 Question: Is duct cleaning required?

> Bid RFI 1 Response: Duct cleaning of existing distribution systems is not a requirement.

2. Bid RFI 2 Question:

23 05 93 reference testing and balance, are we to have an either NEBB or a AABC testing, and balance firm perform a pre-read and then balance the new equipment to match the existing?

Bid RFI 2 Response:

The new roof top units and distribution devices shall be balanced to the original as-built conditions. As-built drawings can be issued by owner for balancing purposes.

3. Bid RFI 3 Question:

3.01B of 23 09 23 (for Tovashal) calls for all 24vdc to be installed in metallic conduit. Should this specification refer to 24vac as well? In addition, if the existing control wiring is not already in metallic conduit it would require a lot of cutting and patching of walls and ceilings to accomplish this. Recommendation would be to utilize plenum rated wire for 24 vac or less.

Bid RFI 3 Response:

Specification Section 23 09 23 Direct Digital Control System for HVAC has been deleted in its entirety. This scope has been removed. Please refer to District Bid Addendum 03 issued October 18, 2022.

4. Bid RFI 4 Question:

Is there an engineer's estimate for the Murrieta Valley USD Tovashal and Thompson HVAC Replacement Project?

Bid RFI 4 Response:

For total Rough Order of Magnitude (ROM) cost for both Tovashal and Thompson, refer to District Bid Addendum 02 issued on October 11, 2022.

5. Bid RFI 5 Question:

Per the bid form, the bidding contractors are to include an allowance of \$75,000.00. But per specification section 01 20 00 Price and Payment Procedures – each school is to include an allowance of \$50,000. Please advise which one is correct.

Bid RFI 5 Response:

The District will keep the allowance of \$75,000 for the entire project per the current Division 00 specifications and current bid form. Refer to Document 00 41 13 "Bid Form and Proposal" included in District Bid Addendum 03 issued October 18, 2022. The document has the allowance amount indicated.

6. Bid RFI 6 Question:

Per Addendum 01 – Section 1 Subsection 1.1 "Table of Contents" – it lists Specification Section 28 01 00 – "Electronic Safety and Security General Provisions" and Specification Section 28 30 00 "Fire Alarm System". Please advise where the bidding contractors can locate them.

Bid RFI 6 Response:

The two specification entries were provided in error. They have been eliminated from the Spec table of contents. Refer to District Bid Addendum 03 issued October 18, 2022.

7. Bid RFI 7 Question:

Per addendum 01 – Specification Section 23 09 23 "Direct Digital Control System for HVAC" states that the controls are Carrier. But the rooftop air conditioners are Trane Corp. Please confirm that this is correct.

Bid RFI 7 Response:

Specification Section 23 09 23 Direct Digital Control System for HVAC has been deleted in its entirety. This scope has been removed. Please refer to District Bid Addendum 03 issued October 18, 2022. The revised DSA addenda drawings included in the District Bid Addendum shows the removal and reinstallation of the Carrier I-Vu boards to maintain communication with District Campus Wide Carrier BMS Systems.

8. Bid RFI 8 Question:

Reinforcement shown on S-2.C and 4,6/S-3.1 indicate that the ceiling and nonbearing wall below AC 1-C would need to be opened up for alterations, please confirm. If the ceiling and wall are to be opened up and altered, can the ceiling height and type be provided?

Bid RFI 8 Response:

The degree to which the existing walls and ceilings are opened for the scope of work is part of the contractor's means and methods. The existing suspended ceiling height in the approximate area below the proposed HVAC work is at 8'-8", but this should be field verified by the contractor.

9. Bid RFI 9 Question:

Reference to Price and Payment Procedures in the Project Manual, please verify/clarify/confirm and provide details of application / inclusion of Cash Allowances if applicable or otherwise in the Contractor's estimate and/or Bid Form. Is there a specific amount to be considered as Cash Allowance? Please confirm this has no relation to the Allowance of \$75,000.00 on the Bid Form or otherwise.

Bid 9 Response:

Please refer to the updated Specification Section 01 20 00 Price and Payment Procedures for both project manuals included in Tovashal DSA Addendum 03 and Thompson DSA Addendum 02 (attached). Under Section 1.2 Cash Allowance, the Bidder is referred to the Division 00 documents and current bid form. The District will keep the allowance of \$75,000 for the entire project.

10. Bid RFI 10 Question:

The Price and Payment Procedures of both Project Manuals, a Contingency Allowance each of \$50,000.00 is indicated. Please confirm this has no relation to the Allowance of \$75,000.00 on the Bid Form or otherwise.

Bid RFI 10 Response:

Please refer to the updated Specification Section 01 20 00 Price and Payment Procedures for both project manuals included in Tovashal DSA Addendum 03 and Thompson DSA Addendum 02 (attached). The section regarding the contingency allowance has been removed in its entirety. The District will keep the allowance of \$75,000 for the entire project.

11. Bid RFI 11 Question:

What is the estimate for the entire project?

Bid RFI 11 Response:

For total Rough Order of Magnitude (ROM) cost for both Tovashal and Thompson, refer to District Bid Addendum 02 issued on October 11, 2022.

12. Bid RFI 12 Question:

Does the Owner have a Baseline Schedule for this project? Is there Phasing?

Bid RFI 12 Response:

For the start and end dates of construction, please refer to the "Time for Completion" Section of the Agreement Document 00 52 13 in the Bid Documents issued in District Bid Addendum 03 dated October 18, 2022. There is no phasing in this project.

13. Bid RFI 13 Question:

Is IAQ Testing required for this project?

Bid RFI 13 Response: There are no IAQ testing requirements in the mechanical specifications.

14. Bid RFI 14 Question:

Will the schools provide staging areas and/or site storage and security for the equipment as part of the rigging/installation process?

Bid RFI 14 Response:

Staging areas will be provided on the asphalt play areas at each school after school is out of session (After June 5th, 2023). Please see the attached exhibits showing the proposed staging areas hatched in red. There are security cameras on site, however, the contractor can provide additional security if they feel that is not sufficient.

We missed the first job walk. Is the job walk mandatory to bid? Will there be a 2nd job walk?

Bid RFI 15 Response:

The job walk was mandatory and there will not be a 2nd job walk.

Substitution Request Response:

BACnet controls have been deleted from the scope of work. Refer to District Bid Addendum 03 that was issued on October 18, 2022. 

 - 2. The defective Work will be partially repaired to the instructions and satisfaction of the Architect and the listed schedule of value will be adjusted to reflect a new value at the discretion of the Architect.
- 1.6 NON-PAYMENT FOR REJECTED WORK
 - A. Payment will not be made for any of the following:
 - 1. Products wasted or disposed of in a manner that is not acceptable.
 - 2. Products determined to be unacceptable before or after placement.
 - 3. Products not completely unloaded from the transporting vehicle.
 - 4. Products placed beyond the lines and levels of the required work.
 - 5. Products remaining on hand after completion of the work.
 - 6. Loading, hauling and disposing of rejected products.

1.7 CHANGE PROCEDURES

- A. The Architect will advise of minor changes in the Work not involving an adjustment to Contract Sum/Price or Contract Time as authorized by General Conditions on AIA Form G710 Architect's Supplemental Instructions.
- B. The Architect may issue a Proposal Request which includes a detailed description of a proposed change with supplementary or revised Drawings and specifications. Proposal Requests are for information only and are not to be considered instructions to stop the work or to execute the proposed change. Contractor will prepare and submit a detailed estimate within 14 days.
- C. Any change in the Work which involves the adjustment to contract sum/price or contract time shall be properly certified by the Contractor as indicated in the General Conditions of the contract.
- D. The Contractor may propose a change by submitting a Change Order Request to the Architect, describing the proposed change and its full effect on the Work. Include a statement describing the reason for the change, and the effect on the Contract Sum and Contract Time with full documentation and a statement describing the effect on Work by separate or other contractors.
- E. Stipulated Sum Change Order: Based on Proposal Request and Contractor's fixed price quotation or Contractor's Change Order Request as approved by Architect.
- F. Time and Material/Force Account Change Order: Submit itemized account and supporting data after completion of change, within time limits indicated in the General Conditions of the Contract.

- G. Maintain detailed records of work done on Time and Material/Force Account basis. Provide full information required for evaluation of proposed changes, and to substantiate costs for changes in the Work as indicated in the General Conditions of the Contract.
- H. Construction Change Directive: Architect may issue a directive, signed by the Owner and Architect, instructing the Contractor to proceed with a change in the Work, for subsequent inclusion in a Change Order. Document will describe changes in the Work, and designate method of determining any change in Contract Sum or Contract Time. Promptly execute the change.
- I. Allowance Adjustment: Adjustment of allowance amounts shall be based upon a properly documented and detailed Change Order Request which substantiates distribution of allowance amounts and actual costs of work in place.
- J. Change Order Forms: AIA G701 Change Order.
- K. Execution of Change Orders: Architect will issue Change Orders for signatures of parties as provided in the General Conditions of the Contract.
- L. All addenda (changes and/or revisions prior to award of contract) and construction changes (changes and revisions after award of contract) shall be approved by the Architect and the Division of the State Architect prior to start of construction covered by those changes and/or revisions in accordance with the requirements of Title 24 of the California Code of Regulations, Part 1, Section 4-338.
- M. Promptly revise Schedule of Values and Application for Payment forms to record each authorized Change Order as a separate line item and adjust the Contract Sum.
- N. Promptly revise progress schedules to reflect any changes in Contract Time, revise sub-schedules to adjust times for other items of work affected by the change and resubmit.
- O. Promptly enter changes in Project Record Documents.

1.8 UNIT PRICES

- A. A unit price is an amount proposed by the bidder and stated on the Bid Form as a price per unit of measurement for materials or services that will be added to or deducted from the Contract Sum by change order in the event the estimated quantities of work required by the Contract Documents are increased or decreased.
- B. Unit prices shall include all necessary material, overhead, profit and applicable taxes.
- C. The Owner reserves the right to reject the Contractor's measurement of work-in-place that involves use of established prices, and to have this work measured by an independent surveyor acceptable to the Contractor at the Owner's expense.
- D. Refer to individual specification sections for construction activities requiring the establishment of unit prices.
- E. Specification sections referenced in the Schedule of Unit Prices contain requirements for materials and methods described under each unit price.
