COURSE DESCRIPTION:

The goals of this course are to provide fourth year students with information, resources, and strategies to help them broaden their proficiency in reading, writing, listening, and speaking French, while encouraging students to experience different cultures and perspectives and to prepare students for the IB French HL or SL examination.

COURSE CONTENT OBJECTIVES:

Curriculum is designed to teach students cultural aspects relevant to the French speaking culture while improving grammar and speaking skills. Over the course of the year we will continue to develop higher level language speaking, reading and writing proficiency skills. Concepts studied include but are not limited to communicating, acquiring information, experiencing creative works, and understanding cultural influences. ABSENT WORK MAKE-UP POLICY: (per MVHS Student Handbook page 10)

When a student is absent from school, ***it is his/her responsibility to contact teachers upon returning to school regarding make-up work.*** Class time is used for instructional purposes. EXAMINATION EXPECTATIONS

By enrolling in an IB course, the student is held accountable for all curriculum and assessments as required by IB, which includes both internal and external assessments. A student who elects to not take the official IB exam in May will then be required to take an alternate exam commensurate to the official IB exam for the course.

GRADE CATEGORIES AND WEIGHTS:

Category	Weight
Demonstration of Progress This includes: Tests, Quizzes, Projects, Oral presentations, etc	50%
Process: Completion of Course Requirements This includes: participation in classroom activities, completion of in class assignments, oral responses and communicative activities in French during class, notebook checks and class notes	30%
Homework This includes: completion of homework, and projects and assignments completed outside of class.	20%

ACADEMIC HONESTY STATEMENT

Academic dishonesty includes but is not limited to: cheating, copying from other sources, using online translators, and/or turning in work done by anyone other than the student. Students caught cheating or copying will receive a zero for that assignment and/or a referral to the office. **USE OF AN ONLINE TRANSLATOR EQUATES TO CHEATING. There are no exceptions!!**

According to *General Regulations Diploma Programme* (2015, p12-13), the IB Organization defines academic misconduct as “behavior (whether deliberate or inadvertent) that results in, or may result in, the candidate or any other candidate gaining an unfair advantage in one or more components of assessment.” Behavior that may disadvantage another candidate is also regarded as academic misconduct. Academic misconduct is a breach of these regulations and includes, but is not restricted to, the following:

- plagiarism—this is defined as the representation, intentionally or unintentionally, of the ideas, words or work of another person without proper, clear and explicit acknowledgment. This includes paraphrasing sources, which also need to be cited properly.
- collusion—this is defined as supporting academic misconduct by another candidate, for example, allowing one’s work to be copied or submitted for assessment by another
- duplication of work—this is defined as the presentation of the same work for different assessment components and/or DP core requirements

d. misconduct during an IB examination (for example, taking unauthorized material into an examination, behavior that disrupts the examination or distracts other candidates, or communicating with another candidate)

e. any other behavior that gains an unfair advantage for a candidate or that affects the results of another candidate (for example, falsifying a CAS record, disclosure of information to and receipt of information from candidates about the content of an examination paper within 24 hours after a written examination via any form of communication/media).

CONSEQUENCES OF ACADEMIC MISCONDUCT

All MVHS consequences will be followed. In addition, the IBO has outlined the penalties imposed on a candidate found guilty of malpractice during an assessment (internal or external). The penalties that the IBO can impose are listed below:

- No score being awarded for the subject.
- Zero marks will be awarded for the assessment component concerned, but the candidate will still be eligible for a grade in the subject concerned.
- Or no penalty if there is no discernible evidence of malpractice.
