President Diffley welcomed the community in attendance and expressed his appreciation for these meetings, emphasizing their importance as a platform for community input and orderly comments.

Murrieta Canyon Academy student representative, Gavin Larson, reported on the start of the school year, academics, Phoenix activities, guidance and leadership, and culture and climate.

Vista Murrieta High School Principal student representative, Taylor Arun reported on academics, athletics, activities and upcoming events.

3. Public Comment

The following individuals provided comments related to agenda item G.1 Approval to Rescind Board Policy 5020.1 - Parental Notification: in opposition of -Christopher Reeves, Eleanor Briggs, Rachael Heida, John Leonard, Beth Fournier, Todd Fournier; in support of - Yvonne Munoz, Jeremy Murphy, and Emily Brooks.

Emily Brooks spoke about comments made by Mr. Pardue and Mrs. Vandegrift at last month's meeting regarding the questionable legality of board candidates, board members and Dr. Andrus' attendance at a CSEA lunchtime meeting. Ms. Brooks wanted to clarify that the board confirmed no legal action was needed, as everything was done properly.

Francis Burns expressed concerns about school board campaign signs suggesting teacher support for three specific candidates. He believes the signs are misleading because the decision to support those candidates was made by the union executive board, not through an objective process involving all teachers.

Kelly Parsons commented on the fantastic start to the new school year and praised the school sites for their efforts to get all students involved on campus.

Greg Langworthy talked about the importance of following Robert's Rules of Order during the meeting and also stressed the importance of teamwork between teachers and parents in raising children.

Jack Guerrero shared his opposition to the district purchasing property for a new school and to rescinding Board Policy 5020.1 - Parental Notification.

Lucky Harutunian talked about the Supreme Court case Board of Education v. Pico, 457 U.S. 853 (1982) which addressed the authority of school boards to remove books from the library that do not align with the district's educational mission or meet the needs of students.

Francis Burns spoke about student discipline policies and his desire to hear Board members discuss the topic.

Jolinne Cochran shared her frustration with an unnamed board member's immature behavior.

Jose Careno spoke about union funds being directed to certain board candidates, specifically mentioning Mrs. Lunn and Ms. Young.

Steve Campos stressed the importance of parental notification in school decisions, sharing his opposition to rescinding Board Policy 5020.1 - Parental Notification. He also raised concerns about union endorsed board candidates.

Jeremy Murphy stated that he appreciates the Board for their foresight in planning for future growth. He criticized board members Nick Pardue and Julie Vandegrift for allegedly defaming other members at a previous meeting.

Kris Thomasian also criticized Mr. Pardue and Mrs. Vandegrift for accusing fellow board members of potentially committing a felony related to their attendance at the CSEA lunch meeting.

Jamie Gobel criticized Julie Vandegrift's recent voting decisions, opposing placing a bond measure on the November ballot and supporting Board Policy 5020.1 - Parental Notification despite the illegality of the policy.

A petition to reject the proposed school site at Ivy and Hayes signed by approximately 257 people was submitted to the Executive Assistant along with slides of the area during wildfires and flooding from a homeowner in the area.

4. Employee Organization Reports

Lisa Murray, President of Murrieta Educators Association, said that while Francis Burns has the right not to be a member of the Murrieta Educators Association, he does not have the right to speak on behalf of its members. Ms. Murray explained the tedious process the association conducts prior to endorsing school board candidates, including interviews by the PAC committee who then sends their recommendations to the executive board. She also clarified that MEA filed a PERB charge to ensure the district follows state law when implementing new mandates for teachers.

Sheryl Alvarado, First Vice President, California School Employees Association, Murrieta Chapter 223, thanked the board, community members and the district for their collaborative partnership in supporting classified staff. She encouraged staff and Board members to also get to know the classified staff when they visit school sites.

4. Approval of Amendment to Employment Contract for District Superintendent, Dr. Ward Andrus, Effective July 1, 2022 through June 30, 2026

President Diffley read the following excerpt from Dr. Andrus' evaluation: Finishing his second year as superintendent of the Murrieta Valley Unified School District, Dr. Andrus has shown considerable expertise managing all aspects of the district. In addition to building trust with, and giving valuable training to, three new Board members, Dr. Andrus continues to emphasize student achievement using data-driven information, at the same time investigating new, innovative methods for reaching all students, including those students who struggle. The Board recognizes that as an asset to the district, Dr. Andrus demonstrates vision, evidence-based decision making, and determination in developing a coherent, instructional educational plan. We look forward to the continued success of the Murrieta Valley Unified School District, in the 2024/25 school year, with Dr. Andrus leading the team as Superintendent.

Prior to taking final action, Government Code section 54953 requires an oral summary of the recommendation for approval on the salaries, salary schedules, or compensation paid in the form of fringe benefits of a local agency executive during open session of a regular meeting in which the final action is to be taken. Accordingly, I am providing an oral summary of the recommendations being considered by the Board today: As reflected on the amendment, the Superintendent's annual salary shall be (\$352,146.00) effective July 1, 2024, and becomes (\$355,668.00) effective January 1, 2025. The Superintendent shall receive a onetime off-schedule one percent (1%) payment. The Amendment also modifies retiree health benefits eligibility to be consistent with terms applicable to other certificated management employees.

President of the Board of Directors, Paul Diffley, adjourned the Murrieta Valle Unified School District Public Financing Authority meeting and reconvened the Board of Education meeting at 7:53 p.m.

K. SUPERINTENDENT REPORT

Superintendent, Dr. Ward Andrus, expressed his appreciation for the community's support for our schools, highlighting booster clubs, PTA and PTC fundraising activities. He spoke about the regular use of school buildings by the community for various activities, including clubs, practices and church events under the Civic Center Act. Dr. Andrus reported visiting many classrooms in the past weeks, observing the positive impact of teachers' professional learning teams on student instruction and witnessing the positive changes on elementary playgrounds due to the implementation of Playworks. He announced the future expansion of Family Services as a result of the board's approval to purchase the Promise Church property. Dr. Andrus shared his appreciation for the Board's confidence in his evaluation and said he is looking forward to serving the district in the future.

L. BOARD MEMBER REPORTS

Trustee Julie Vandegrift said that this time of the year is particularly busy for her as she stays updated with board activities and engages with community members to gather their feedback. Mrs. Vandegrift also completed the Keenan Safe School training and met with a few administrators, sharing her appreciation for the teacher's efforts to keep programs running.

Trustee Linda Lunn said she has had extensive interactions with students, parents, and staff over the past month, which has been very positive, fulfilling, and heartening to see the strong support for our district. Mrs. Lunn mentioned that she introduced Boosterthon to California when she was the Lisa J. Mails PTA president and was very pleased to hear that \$70,000 was raised this year by Lisa J. Mails PTA.

Trustee Nicolas Pardue reported visiting E. Hale Curran Elementary, Rail Ranch Elementary, Murrieta Elementary, Murrieta Valley High, and Thompson Middle, and highlighted the positive experiences and professionalism of the staff. Mr. Pardue said he felt misled about the purchase of the property at Ivy and Hayes and the bond issue, stating he wants to see more transparency from the district towards the community. He also questioned the necessity of a new school, stating that existing schools have sufficient

space to meet the current needs. Mr. Pardue expressed concerns about declining academic standards and discipline issues as a result of failed state policies.

Trustee Nancy Young reported attending the Riverside County Office of Education Equity Conference in Palm Springs and the African American Parent Advisory Council meeting. Ms. Young spoke about the Santa Rosa Plateau's field trip program which offers an educational hike and mentioned that Murrieta Elementary third grade students were the first to attend this school year. She also reported completing the statemendated Ethics Training course.

Trustee Paul Diffley reported spending a significant amount of time completing the Superintendent's evaluation and thanked his fellow Board members for their collaboration. He said he is looking forward to enjoying all the extra activities the holiday season brings to the school sites. Mr. Diffley also noted his excitement about the new "Golden Senior Pass", which offers free and/or discounted entry to high school drama productions for senior citizens.
