1. Student Representative Reports

High school student representatives reported on school academics, activities, athletics and upcoming events.

2. Public Comment

Anna Pham spoke about student representation on the Board of Education and requested that a student board member be selected starting with the 2022/23 school year and continuing each school year thereafter.

Kelly Parsons complimented the educators at Lisa J. Mails, stating that her experience as a parent has been amazing.

Clair Bolasky, RSP Teacher at Murrieta Valley High School commented on her experience in the classroom trying to make up for the learning loss students experienced in math during the COVID 19 pandemic. She also advocated for continuing to offer Earth Science at the high school level.

Rachel Fish, Shannon Saliba, Alida Pastizzo, Johanna Zeitman, Carly Fulks, Patty Smith each provided individual comments regarding large class sizes in elementary and SDC classes.

Frances Burns commented on the candidates for School Board in the upcoming election.

Sue Stein requested that all cell phones be removed from the classroom.

3. Employee Organization Reports

Kimberly Binning-Chevlin, President, Murrieta Educators' Association, shared the teacher's concerns about class sizes and being overwhelmed with the task of addressing learning loss due to the pandemic.
