## 2. Recognition of Board Member, Kris Thomasian

Dr. Ruth Perez, Deputy Superintendent, Riverside County Office of Education, Assemblymember Seyarto and Senator Melendez's offices, City of Murrieta, Murrieta Valley Unified School District Board of Education and Murrieta Educators Association each presented Mrs. Thomasian with Proclamations, Resolutions and awards to honor her thirty plus years of service to the students of Murrieta Valley Unified School District as a community member and a member of the Board of Education.

#### 3. Public Comment

Murrieta Valley High School students Anna Pham and Mya Prasad advocated for the selection of a Student Board Member.

Sarah Caskey commented on student behavior in the classroom and stated that teachers need more support from district staff regarding student behavior.

## 4. Employee Organization Reports

Kimberly Binning-Chevlin, President of the Murrieta Educators' Association, said that they are all looking forward to the chance to recharge and spend time with their families during the holiday break. She also stated that teachers are struggling with extreme behaviors in the classroom and asked for the necessary support and training for all district educators.

Freddie Musquiz, President California School Employees Association, Murrieta Chapter 223 reported on the conclusion of transportation negotiations and that they anticipate signing the MOUs very shortly. He thanked Kris Thomasian for all her years of dedication to the Murrieta Valley Unified School District community.

## 5. Superintendent Report

Dr. Andrus said this has been a fabulous month in Murrieta. He mentioned the Rotary sponsored Field of Honor, saying it was a remarkable experience and he was delighted to be personally involved.
