4. Public Comment

Francis Burns directed his comments to Lisa Murray, President of the Murrieta Educators Association, expressing his disappointment that she had shared personal information about him at the last public meeting. He warned that if she disclosed personal information again in a public forum, he would file a lawsuit. He also mentioned that his reason for leaving the union was due to a difference of political views.

5. Employee Organization Reports

Lisa Murray, President of the Murrieta Educators Association, stated that MEA represents over a thousand educators dedicated to the students and future of the school district. She emphasized the need for the district to focus on critical educational goals beyond test scores, creating safe and supportive learning environments, and providing educators with the necessary resources and respect. Mrs. Murray highlighted the importance of policies that prioritize students and teachers, grounded in research and informed by educators. She also shared concerns about recent distractions and lack of basic supports in the classrooms, such as dealing with student behavior issues, large class sizes, outdated facilities and underfunded programs. Mrs. Murray concluded by commending Paul Diffley and Linda Lunn for their dedication to the schools and district, recognizing the difficulties of their roles as Trustees, and wished them all the best in the future.

Student Board Member, Sophia Shoemaker, reported on the various topics discussed at the Student Advisory Council meeting on November 7th. The first topic was a podcast and potential subject matter that would be discussed regarding high school campuses. There was also discussion about phone usage and self-regulation within the classroom, the condition of campus bathrooms, the early release schedule, and how to effectively utilize office hours.

6. Learning Update No. 1 Presentation

Educational Services staff presenters: Assistant Superintendent Faythe Mutchnick-Jayx, Executive Directors Joe Parla and Jennifer Schriver, and Coordinator Robert McGonigal

Educational Services staff reviewed CAASPP, CAST, A-G completion rate and graduation rate data and compared the 2023/24 data alongside the 2018/19 pre-pandemic, the 2021/22 and 2022/23 data. Overall, the summative assessment data is trending in a positive direction from the prior two years. All students, SED students and students with disabilities have two consecutive years of improved outcomes in English Language Arts, math and science. Mathematics and A-G rates continue to be areas for needed growth. Graduation rates continue to be exemplary. It was reported that the California School Dashboard data is expected to be released on December 1, 2024.

E. SUPERINTENDENT REPORT

Superintendent, Dr. Ward Andrus shared information about the senior citizen VIP pass which grants anyone aged 60 or over free lifetime access to Murrieta Valley USD Visual and Performing Arts events at district high schools. Dr. Andrus highlighted various school site events, including fall festivals, trunk-or-treat activities and the Murrieta Rotary Club's 16th annual Field of Honor event. He recognized the fall athletics programs for their successful season. Dr. Andrus concluded his comments by encouraging all parents and community members to review the boundary map presentations posted on our website and to attend the December open house meetings to review the proposed new boundary maps and provide their input via surveys to follow.

F. BOARD MEMBER REPORTS

Trustee Julie Vandegrift discussed the ongoing redistricting efforts and encouraged parents to visit the district website for more information. Mrs. Vandegrift highlighted the importance of the science of reading, mentioning successful stories and the district's efforts to train teachers with the LETRS program. She mentioned a recent bill to mandate the science of reading in California schools failed, partly due to opposition from the California Teachers Association.

Trustee Nancy Young shared her recent activities, including attending Unified Sports at Warm Springs Middle School, the fall joint meeting of the Riverside and San Bernardino counties Board of Education, the AAPAC and ELPAC parent advisory council meetings. Ms. Young reflected on the significance of Veterans Day, due to her military family background and the Rotary Club Field of Honor events.

Trustee Nicolas Pardue emphasized the importance of community representation and communication, especially regarding roles and responsibilities of the board. He highlighted the dedication of teachers and the strong community ties. Mr. Pardue discussed the need for transparency about academic scores and the importance of focusing on academic skills to prepare students for the future. He also addressed classroom discipline, stressing the need for safe learning environments and the importance of supporting teachers while adhering to legal requirements. He encouraged parents to start weighing in on the upcoming boundary changes as soon as possible. Lastly, Mr. Pardue expressed gratitude to Julie Vandegrift for her thorough research and preparation for school board meetings.

Trustee Paul Diffley agreed that the teachers are facing tough environments with diverse student needs, and there's a call for more support and workshops to address these challenges and classroom distractions. Mr. Diffley praised the district's drama departments and highlighted impressive student performances in *It's a Wonderful Life* and *In To the Frying Pan*. Mr. Diffley suggested organizing reading contests to encourage students and proposed exploring Middle School CTE programs to build foundational skills for high school.
