1. Student Representative Reports

Murrieta Valley High School student representative, Meghan Lewis, reported on academics, athletics, activities and upcoming events.

Murrieta Mesa High School student representative, Haven Anozie reported on academics, athletics, activities and upcoming events.

Vista Murrieta High School student representative, Alana Elliott, reported on academics, athletics, activities and upcoming events.

2. Superintendent Report

Superintendent, Dr. Ward Andrus said the District was honored to receive a certificate of recognition from State Senator Kelly Sayarto for our contribution to the Veterans Expo, providing employment opportunities to veterans. He reported that the District also hosted Assemblywoman Sanchez's Fentanyl Town Hall meeting. Dr. Andrus attended high school athletic events and drama productions and participated in the Field of Honor with over 1,556 fifth graders attending. He announced that the District would be awarded a Golden Bell at the California School Boards Association Annual Education Conference later this month for inclusion efforts, recognizing our commitment to integrating students with disabilities into regular education classes and experiences, fostering empathy and meaningful connections among students.

Angela Burch, Teresa Wells, Karen Poznanski, Robert Seneff, Jamie Goebel, discussed their dissatisfaction with Board member behavior, lies and divisiveness.

Lucky Harutunian discussed student test scores and her suggestion to refocus on academics and leave political activities out of the classroom.

Pam Barret spoke about the upcoming Veterans Holiday and encouraged the audience to attend the Murrieta Field of Honor.

Kris Thomasian expressed concerns with Pro Bono legal service providers and urged the Board not to entertain their offers.

Jane DeLaurier expressed concerns about Board Policy 5020.1- Parental Notification and potential ramifications stemming from the requirement to notify parents if a student requests to identify as a gender other than the student's biological sex or gender listed on the student's birth certificate.

Arthur Amor shared concerns about Julie Vandegrift's comments regarding gender transition being encouraged in Murrieta Schools.

Rudi Krause commented about vaccinated people, critical race theory, and the homosexual community.

4. Employee Organization Reports

Kimberly Binning-Chevlin, president of Murrieta Educators Association spoke about the crucial role elementary arts and PE programs play in enhancing students' social-emotional development. Mrs. Binning-Chevlin highlighted MEA member, Adriana Toon's presentation at the CTA LGBTQ Plus Conference that offered practical strategies for educators to create inclusive classrooms, emphasizing sensitivity and awareness. She expressed her appreciation for the educators' hard work and said everyone is looking forward to the upcoming break.

Trustee Nancy Young reported attending the Key Communicator Forum, the San Bernardino County/Riverside County School Board's Association Fall Joint Meeting, Supporting the Whole Child Superintendent's Advisory Council meeting, Rotary luncheons, Field of Honor events, Student of the Month breakfast and visiting E. Hale Curran Elementary, Murrieta Valley and Murrieta Mesa high schools, and chaperoning Vista Murrieta High School's CTE Engineering field trip.

Trustee Julie Vandegrift encouraged everyone to check in on any Veterans in their family during this Veterans Day holiday. Mrs. Vandegrift read excerpts from a Press Enterprise Article regarding student suspensions and the toll they take on "at risk kids". She reported attending the Supporting the Whole Child Superintendent's Advisory Council meeting and shared her concern about the Centers for Disease Control's (CDC) involvement in education, expressing her opinion that schools should focus on education and the CDC should focus on health.
