# 2. Superintendent Report

Dr. Andrus commented on the many activities taking place at each school site during the holiday season and shared his appreciation for staff, parents and community members for their efforts in providing such a rich education to the students. He welcomed the three new Trustees and said he was delighted to report that they have all expressed their desire to continue the high quality product Murrieta Valley Unified School District has in place. Dr. Andrus praised Linda Lunn, Zhanna Preston, Jason Cantu, Ryan Heise, and Jacquie Acosta for their presentation on Murrieta Valley USD's Inclusion Project at the California School Board Association Annual Education Conference. He congratulated Vista Murrieta High School Activities Director, Shannon Kush, for being awarded the Bob Burton Spirit Award.

## 3. Public Comment

Bob Kowell, Regina Duncan, Tim Thompson, Josephine Hartley, Jacquie Acosta, Simon Cooper and Daniela Azimiora each individually congratulated new Board members Nick Pardue, Julie Vandegrift and Nancy Young. Some shared their hope that the School Board remains a nonpartisan body focused on the best outcomes for students; others shared their hope that parent rights would become more prominent in education.

Stephanie Holloway shared her support and concern for inclusive teachers who adhere to the FAIR Education Act.

Lucky Harutunian referenced surrounding school districts who she said are going to do away with CRT and implored Murrieta Valley to follow suit.

Jennifer S. advocated for equal opportunity for all non-verbal special education students and asked for the exploration of a Board Policy pertaining to non-verbal student rights.

Sara Caskey thanked Dr. Zhanna Preston for spending an hour in her classroom and providing constructive criticism, strategies to improve students' behavior and to address violence at the elementary level in response to her public comment at the last meeting.

### 4. Employee Organization Reports

Kimberly Binning-Chevlin, President, Murrieta Educators Association commented on the stress educators are experiencing during this school year. She said teachers are experiencing severe student behaviors in the classroom that were not present prior to the pandemic. Mrs. Binning-Chevlin reported that Murrieta Educators' Association and the district negotiated advancements in the salary schedule last year, but inflation has made those advancements moot. She reported attending a co-teaching inclusion check-in meeting at Shivela Middle School which began the planning process for enhancements to the co-teaching model for next year.

Mr. Chris Schultz spoke on behalf of Murrieta Educators' Association Executive Board and bargaining team regarding opening items for the 2023/24 bargaining. He stated that MEA anticipates being on the same expeditious timeline as the negotiations were last year. Mr. Schultz said the MOU around TK expansion is still in the works and that the top priorities from the members survey were hours, duties, elementary class size, salary schedule increase and an increase in the benefits cap.

Freddie Musquiz, President, California School Employees Association, Murrieta Chapter 223 welcomed the new Board members. He reported that four out of the five MOUs recently passed ratification. He reported that CSEA will be working on re-openers for next year and is looking forward to this year's negotiations.

Board member Nancy Young expressed her gratitude for being elected to support students, parents and staff of the Murrieta Valley Unified School District. Mrs. Young said she takes her role very seriously and has attended all the training courses the district has offered to new Trustees and the California School Board Association Orientation for New Board Members. She expressed her interest in learning more about the district's induction program and CTE programs.

Board Member Julie Vandegrift shared that she was elected by her neighbors in trustee area 3 where she and her husband raised and homeschooled their six children. She said she is very honored and humbled to be elected to the Board of Education and she intends to represent the wishes of the community in a leadership role in collaboration with all stakeholders. Mrs. Vandegrift reported that her focus would be student learning, campus safety and respect for each family's values. She thanked the community for placing their trust in her and her fellow Board members.

Board member Nicolas Pardue thanked his constituents for supporting him in the recent election. He said he has been a teacher for approximately twenty-five years and sees himself as an advocate for those students who don't really like school. Mr. Pardue expressed his desire to have the district expand the CTE programs currently offered to students. He stated that he would like people to understand that political differences don't make people evil and that people need to learn to be more responsible for their rhetoric.

Board Member Linda Lunn reported visiting Palomar Health Center's Middle School Science Center to learn about careers and professions that are available in this field for students with or without a four-year college degree. She attended Murrieta Valley's Rudolf the Red Nose Reindeer and the California School Boards Association conference with representatives throughout the state. Mrs. Lunn said she was very proud to be a part of the team presenting at the CSBA conference on the "Inclusion Trifecta" which is about including all special education students in every activity, sport and leadership opportunity. Mrs. Lunn said she is looking forward to a new year and getting back to focusing on student achievement now that all the campaigning is over.

Board member Paul Diffley welcomed the new Board members to their positions. He stated that he is hopeful the Board can have respectful disagreements and operate without fear so they can and just do the things they were elected to do. Mr. Diffley reported participating in the annual Share the Harvest event held at Murrieta Mesa High school and the Walk through the Revolution at Murrieta Elementary School.
