## **C. COMMUNICATIONS**

### **1. Student Representative Reports**

Murrieta Canyon Academy student representative, Gavin Larson, reported on academics, activities and upcoming events.

Vista Murrieta High School student representative, Isabella Acosta reported on academics, athletics, activities and upcoming events.

Murrieta Valley High School student representative Meghan Lewis, reported on academics, athletics, activities and upcoming events.

Murrieta Mesa High School student representative Caitlin Coleman, reported on academics, athletics, activities and upcoming events.

### **2. Public Comment**

Jolinne Cochran congratulated the newly elected board members and then shared her concerns about student safety on Murrieta Valley USD campuses.

Kelly Parsons discussed her participation in this year's Project 99 virtual walk. She highlighted how Project 99 works together with families, school staff, and the community to educate and bring awareness about mental health and suicide prevention. She also praised Michelle McCarthy for her endless dedication to the program.

Bob Kowell questioned items on agenda item E.4 Approval of the First Interim Report and Filing a Positive Certification for Fiscal Year 2024/25. He focused on ADA (average daily attendance), enrollment, and salary increases exceeding Cost of Living Adjustment.

Skye de Branwere congratulated the newly elected board members. She spoke about the proposed boundary changes and said those who voted against allowing the bond to be placed on the ballot should be held accountable.

### **3. Employee Organization Reports**

Lisa Murray, President, Murrieta Educators Association, welcomed new and returning board members and encouraged them to actively participate in various school events, including athletic events, open houses, showcases, math and science nights, performing arts shows, award ceremonies, academic competitions, and special events. She emphasized the importance of engaging with parents, students, staff, teachers, coaches, and other school personnel to understand their needs and contributions. Ms. Murray urged board members to be visible, accessible, and approachable, and to have constructive discussions with all stakeholders to ensure the best outcomes for students in the Murrieta Valley Unified School District. She highlighted the need to focus on the district's specific needs and avoid distractions from external political noise. Ms. Murray closed her remarks by wishing MEA members a restful winter break and happy holidays.

### **4. Employee Organization Reports (continued)**

Dr. Andrus read a statement on behalf of Freddie Musquiz, President, California School Employee Association, Murrieta Chapter 223 wishing everyone a happy holiday season. He expressed hope that, following the elections, the community can unite to ensure that Murrieta Valley Unified School District students receive the best possible education. He emphasized the importance of educational achievement and growth, and the need to create a supportive and enriching environment for students, staff and the community. He mentioned that CSEA Murrieta Chapter 223 is currently taking nominations for its executive board and working on a survey for its membership in preparation for upcoming negotiations.

### **5. Superintendent Report**

Superintendent, Dr. Ward Andrus reported on the successful first half of the school year, highlighting the excellent learning experiences observed in classrooms, on stages, fields and courts. He thanked the parent committee and consultant Andrew Bishop for their work on reviewing maps, neighborhoods, and data to develop recommendations for the board regarding attendance boundary options. He also thanked parents and community members who participated in surveys. Dr. Andrus stated that another communication was sent out to nearly 3,000 email addresses of parents and guardians last Thursday regarding the current attendance boundary options. He emphasized the intention to act quickly while maintaining current family attendance patterns and helping new families transition to new schools over the coming years.

### **6. Board Member Reports**

Student Board Member Sophia Shoemaker reported that Vista Murrieta High School held a canned food drive, collecting 4,950 cans. The Broncos honored veterans and military service members through a school-wide learning project, with all classrooms contributing uniquely. Students had the opportunity to learn from a panel of veterans and active-duty members. Miss Shoemaker concluded by thanking those who serve and wishing everyone a happy holiday and New Year.

Trustee Nancy Young reported on her volunteer experience at the annual "Share the Harvest" event at Murrieta Mesa High School. Ms. Young highlighted the valuable learning and networking opportunities with administrators and school board trustees from across California at the California School Board Association's convention. She also attended a boundary meeting at Thompson Middle School along with a PTA meeting at Lisa J. Mails Elementary School, gathering input from concerned parents about upcoming changes. She stressed the importance of focusing on student programs, achievement, well-being, and career opportunities, urging the board to prioritize students over partisan politics.

Trustee Nicolas Pardue spoke about attending the California School Board Association Annual Education Conference and the Pacific Research Institute training, where discussions focused on math and reading scores, and educational programs dating back to the 1980s. He noted a significant decline in basic skills over his 30 years in education and emphasized the importance of addressing this issue. Mr. Pardue discussed the importance of PE standards and promoting health among students and attended boundary meetings to gather parent input. He stressed the need to protect the learning environment and maintain discipline, particularly in junior high, to ensure student success. Mr. Pardue emphasized the importance of focusing on student achievement, well-being, and career opportunities, and expressed his commitment to working as a team to prioritize the safety and success of students and staff.

Trustee Eleanor Briggs shared her positive experience at her first California School Board Association conference, highlighting the opportunity to connect with other board members facing similar issues. She praised Valerie Backus and the CTE team for their impressive presentation and encouraged parents to attend CTE advisory meetings to learn about opportunities for non-college-bound students. Mrs. Briggs thanked the Murrieta PD and district staff for their quick response to a recent incident, stating the importance of student safety. She expressed her desire for a unified board and community, focusing on common goals and prioritizing the well-being of students. She shared her appreciation for everyone involved in the election process and expressed hope for unity and collaboration moving forward.

Trustee Christine Schmidt expressed gratitude to God, her supporters, and her family for their encouragement during the election cycle. She shared her hope that her experience serves as an example to students that they can achieve anything they set their minds to. She attended the PRI California School Board Member Conference, finding it eye-opening, especially regarding the issues behind low math scores. She noted that many attendees were new board members. She also attended a boundary meeting at Thompson Middle School and looks forward to visiting school sites in January. Mrs. Schmidt thanked educators and staff for their dedication throughout the year, acknowledging their continuous efforts even during breaks.

Trustee Yvonne Munoz attended the CSBA conference, finding it highly educational. She highlighted a keynote by Dr. Laurie Santos on the science of happiness, emphasizing the importance of joyfulness and well-being in the workplace. Mrs. Munoz noted that the leadership of the governing body sets the tone for acceptable behavior and collaboration among all stakeholders, including staff, unions, the community, police, and trustees. She attended sessions on navigating the new political landscape and governance, discussing the significant financial impact of conflicts and the need for unity. Mrs. Munoz suggested establishing governance norms and participating in a board retreat to advance the district's mission. She also attended redistricting meetings at Vista and Thompson, where she heard common concerns about distance, traffic, busing expenses, and the impact on extracurricular activities. She emphasized the need for transparency about the financial implications and thanked the community for their participation. Mrs. Munoz closed by expressing optimism about working with the diverse board to represent Murrieta well.

Mr. Whittington stated that the district would be able to meet its financial obligations for the current budget year and two successive fiscal years. However, he also noted that the district will continue to engage in deficit spending for the next three years, making it necessary to keep making appropriate adjustments to mitigate the effects.
