E. COMMUNICATIONS

1. Board President's Welcome Message

President Diffley greeted the attendees. He remarked on the City of Murrieta's ongoing expansion. Mr. Diffley extended congratulations to Dorothy McElhinney Middle, Murrieta Mesa High, and Vista Murrieta High schools for earning the 2024 California Distinguished Schools award and expressed gratitude to the staff whose efforts enabled this achievement. President Diffley emphasized the district's shift in focus from universal college attendance to career readiness.

2024 California Distinguished Schools

The California Distinguished Schools Program was established by the California Department of Education (CDE) in 1985 and recognizes schools that demonstrate exemplary achievements. The California Distinguished Schools Program recognizes elementary and middle and high schools in alternate years. Schools recognized as California Distinguished Schools hold the title for two years. California uses multiple measures to identify eligible schools based on their performance on the state indicators as specified on the California School Dashboard.

4. Public Comment

Karen Poznanski requested the Board rescind Board Policy 5020.1 - Parental Notification

Joline Cochran expressed her displeasure with Nancy Young as a Board member.

Lucky Harutunian spoke about a Homeland Security inspection report indicating deficiencies at five school sites.

Kelly Parsons expressed her support for Board approval to place a bond measure on the November 5th ballot which would allow Murrieta voters to vote for or against a local bond measure.

Rudy Krause shared his opinion of the importance for students to use both hemispheres of the brain when solving problems.

Dr. Steven James stated that he was representing a family in the district as their advocate and shared with the Board that they were disputing the outside investigator's report and would be appealing the findings to the CDE.

Kris Thomasian recommended that the new board members participate in events at the school sites to observe firsthand the positive impact our schools have on the community.

4. Public Comment (continued)

Alex Carranza spoke about issues with the Senior Culminating Project and suggested that it be removed as a graduation requirement and also urged the Board to address the conduct of two male teachers at Murrieta Valley High School who express their political and religious views in the classroom.

Francis Burns advocated for a firm approach towards more serious misbehaviors occurring on middle school grounds to prevent future incidents.

Greg Langworthy spoke about the Children's Protection Act which is aimed at advancing children's well-being and asked the Board to support the initiative.

Theresa Wells urged the community to examine the bond information pamphlets being sent to every household in Murrieta. She requested the Board's approval to place the bond measure on the November 5, 2024, ballot, thereby giving Murrieta's residents the chance to vote on the proposal.

5. Employee Organization Reports

Kimberly Binning-Chevlin, President, Murrieta Educators Association, discussed her involvement in district activities, including the Board planning workshop on February 27, 2024. She reported that MEA and the district had conducted several bargaining sessions, working towards agreements that would benefit educators and students alike. She expressed the association's anticipation for further productive sessions in the upcoming months to address co-teaching and inclusion, TK and Kindergarten schedules, elementary visual and performing arts and supports for specialized student services.

6. Student Board Member Report

Student Board member Isabella Dadalt reported that the central topic of discussion during the Superintendent's Student Advisory Council meeting was on providing refresher courses for seniors. These courses would be designed to equip the students with essential life skills such as job application and resume writing, skills that many may have not utilized since their freshman year.

Review of Associated Student Body Financial Reports for the Quarter Ending December 31, 2023

The Board received this report for review.

H. SUPERINTENDENT REPORT

Superintendent Dr. Ward Andrus extended his congratulations to Dorothy McElhinney Middle, Murrieta Mesa High, and Vista Murrieta High schools for their recognition as Distinguished Schools. He discussed the daylong Board Workshop held on February 27, 2024, where they reviewed the achievements of the previous year and set the goals and direction for the 2024/25 academic year. Dr. Andrus also addressed the Facilities Master Plan and the bond feasibility study's formal poll results, which indicated a 63% approval rate. Dr. Andrus discussed the Career Readiness brochure and how it represents a formal shift in our district's messaging from college for all to forging a career path and recognizing that apprenticeships, college, military careers and trade schools all hold equal value.

I. BOARD MEMBER REPORTS

Trustee Paul F. Diffley reported on activities of the County Committee on School District Organizational meeting which included the swearing in of new members. He attended various middle and high school drama and band performances. Mr. Diffley shared his support for the shift in district messaging from "college for all" to "college and or career ready post high school for all". Additionally, he also shared concern about the ability of the current district facilities to accommodate the number of projected students over the next few years due to increased housing and apartment developments currently under construction.

Trustee Nancy Young reported on her attendance at the following meetings over the past month: Rotary Club, Dollars for Scholars, Superintendent's CTE Advisory Council, Student of the Month breakfast and the Riverside County Office of Education State of Education Address. She attended a field trip to the Ben Clark Training Center in Riverside with high school CTE students and visited Antelope Hills, Tovashal Elementary and Murrieta Canyon Academy.

Trustee Julie Vandegrift encouraged community members to join her in attending the informative Curriculum and Whole Child Superintendent's Advisory Council meetings. She referenced California Assembly Bill AB 2222, which proposed evidence-based literacy instruction with explicit, systematic phonics instruction aligned with the science of reading, and stated her belief that our school district should prioritize core programs that embrace the science of reading. Mrs. Vandegrift discussed the Board's goals and directions for the 2024/25 school year, which were a product of the February 27, 2024 day-long direction setting workshop.

Trustee Linda Lunn said she participated in the California School Boards Association legislative action week, enabling her to meet with local legislators to discuss matters pertaining to public schools. The topics of discussion ranged from the Governor's proposal to borrow \$8 billion dollars from Prop 98 funds to placing a state school facilities bond measure on the ballot. Mrs. Lunn further explained that if the state places a bond measure on the ballot there could be an opportunity for Murrieta Valley USD to receive 50% matching funds should the Board move forward with the decision to place a local bond on the November 5th ballot, giving the voters an opportunity to decide. She also highlighted school activities she attended this month.

Trustee Nicolas Pardue spoke about the Profile of a Graduate, emphasizing a shift in focus from meeting the college A - G requirements and graduation rates to equipping students with life skills and career readiness, rather than only focusing on college as the only path after high school graduation. Mr. Pardue also discussed the dire need to address student behaviors and study habits, especially in middle school.
