F. ACTION/INFORMATION ITEMS

1. Presentation: Student Discipline Policies

Ryan Tukua, Executive Director Student Support, discussed student discipline practices. He reviewed Education Code section 48900, which outlines the framework for suspensions and expulsions. Recent legislative changes, including Assembly Bill 420 and Senate Bill 419, have affected suspension and expulsion policies related to disruption and/or defiance. Protections are in place for students with disabilities and those with Individualized Education Programs (IESs) to ensure equal access to education. Research-based frameworks and strategies, such as Positive Behavioral Interventions and Supports (PBIs) and Multi-Tiered system of Supports (MTSS) are being used as alternatives to suspension and expulsion. This school year, the Playworks program has been introduced at the elementary level under MTSS, teaching students how to interact and play on the playground in a more structured manner. Mr. Tukua closed his presentation by outlining the measures to create positive environments for students and staff, including climate and culture initiatives, aligned consequences and restorative practices between the school district and Murrieta Police Department, and staff support by way of training and safety measures.
