1. Learning Update No. 1 Presentation

Staff presenters: Faythe Mutchnick-Jayx, Assistant Superintendent, Educational Services; Executive Directors Joe Parla and Jennifer Schriver

In an effort to put the data in perspective, staff reviewed the timeline of the last couple of years: 2019/20 in-person instruction ends in March without conducting any state testing or accountability, 2020/21 virtual and hybrid instruction due to the COVID 19 pandemic, 2021/22 return to in-person instruction with full state assessment and dashboard baseline, 2022/23 in-person instruction with full assessment and dashboard accountability.

The staff reviewed CAASPP, CAST, A-G completion rate and graduation rate data and compared the 2021/22 data alongside the 2018/19 data. The data reflected learning loss in mathematics was more significant than ELA and that student groups were more significantly impacted by learning loss than the population at large. Murrieta Valley Unified School District's performance continues to exceed the county average in ELA, math and science and has one of the highest graduation rates in the state.
