c. Superintendent Communication

Superintendent Kelley expressed his sincere thankfulness to the staff of the Murrieta Valley Unified School District for their efforts to mitigate challenges presented by the current labor shortages. He praised the Human Resources department for anticipating the shortages and doing their very best to fill vacancies with a limited substitute pool.

G. EDUCATIONAL SERVICES

1. Prekindergarten Planning and Implementation Grant Plan

Staff presenters: Mary Walters, Assistant Superintendent, Educational Services; Faythe Mutchnick-Jayx, Executive Director, Elementary Education and James Whittington, Chief Financial Officer

Staff presented information and plans for the implementation of universal transitional kindergarten to include all four-year-olds by the 2025/26 school year. California Assembly Bill 130 Section 4 established the Prekindergarten Planning and Implementation Grant to provide school districts with the funds to support planning, hiring and recruitment, professional development, classroom materials and supplies. Murrieta Valley Unified School District is allocated \$300,031 in Prekindergarten Grant funds to be expended by June 30, 2024.

2. Comprehensive School Safety Plans 2021/22

The Board received an overview of the comprehensive school safety plans for the 2021/22 school year for review.

3. First Reading of Proposed Revisions to Board Policies and Administrative Regulations and Proposed New Administrative Regulation

The Board received the following policy/regulation revisions and new regulation for first reading: BP5131.5 - Vandalism and Graffiti BP6000 - Concepts and Roles BP6011 - Academic Standards BP6112 - School Day BP6146.4 - Differential Graduation and Competency Standard for Students with Disabilities BP/AR6173 - Education for Homeless Children BP/AR6173.2 - Education of Children of Military Families AR6116 - Classroom Interruptions

Mrs. Larson suggested edits to BP 6000 – Concepts and Roles and BP 6011 Academic Standards that will be included when the policies and regulations are presented for second reading on February 10, 2022.

4. Williams Uniform Complaints Quarterly Report

The Board received this report indicating that no complaints were filed for the second quarter of the 2021/22 school year.

H. BUSINESS AND OPERATIONS

1. Presentation Regarding Trustee Area Redistricting

The 2020 Census data revealed a total variance between trustee areas of 15.9%. In order to remain in compliance, the total population distribution in trustee areas must be less than 10%. Representatives from Cooperative Strategies prepared two potential maps of adjusted trustee voting areas for review by the Board of Education. The final map will be adopted by the Board at the February 10, 2022 regular meeting.

2. School Start Times for 2022/2023

Staff Presenters: Darren Daniel, Deputy Superintendent; Jennifer Hanshew, Director, Transportation; Jill Lancaster, Director, Nutrition Services; Ryan Tukua, Principal, Murrieta Valley High School

California Senate Bill 328 requires the school day for high schools to begin no earlier than 8:30 a.m. and for middle schools to begin no earlier than 8:00 a.m. beginning July 1, 2022. Staff reviewed the impact the change in start times will have on high school programs, nutrition services and transportation services. It was noted that the middle school start times would not need to change and only five elementary school start times would need to be adjusted slightly to accommodate shifts in transportation needs.
