## A. CALL TO ORDER

President Linda Lunn called the regular meeting of the Board of Education to order at 5:00 p.m. at the Murrieta Valley Unified School District Support Center, 41870 McAlby Court, Murrieta, California.

Mrs. Lunn announced that the meeting was being audio recorded and live stream broadcast, and that a roll call vote would be conducted for each item.

# 4. Recognition of Board Member, Kenneth Dickson

Murrieta City Councilman, Jonathan Ingram presented Mr. Dickson with a Proclamation from the City of Murrieta to honor his service to the school district and community.

Superintendent Patrick Kelley expressed his gratitude to Mr. Dickson for his twenty-four years of dedicated service to the Murrieta Valley Unified School District Board of Education, stating that he has brought incredible strength and wisdom to the Board and community during his many years of service.

Board members Paul Diffley, Linda Lunn, Oscar Rivas and Kris Thomasian each shared fond memories and their appreciation of Mr. Dickson's service on the Board of Education.

## 5. Communications

#### a. Public Comment

Martha Barron, Judy Seaman, Nikki Galindo, Chantelle Grisel, Sue Stine, Kelly Hubbard, Claire Bolasky, Laura Kingman, Benjy and Erin Rench, Kameljit Singh, Samantha Hill, Holly Childs, Francis Burns, and Whitney Moylam each provided public comment in opposition of mandated face coverings and COVID-19 vaccinations and testing for students and employees.

Lucky Harutunian provided public comment in opposition of Critical Race Theory.

Arthur Murphy commented on kids' rights.

Kent Chivington expressed his displeasure with the manner in which the October 28, 2021, Board vacancy applicant interviews and provisional appointment to fill board vacancy was conducted.

# b. Employee Organizations Communication

Kimberly Binning-Chevlin, President of the Murrieta Educators' Association discussed her role as the MEA President, clarified that she is a Teacher on Special Assignment, employed by the Murrieta Valley Unified School District and not a California Teachers Association employee. She stated that she will never lose sight of making MVUSD a better place where we are proud to work and send our children.

Mrs. Binning-Chevlin reported on MEA's participation in Toys for Tots and Project 99. She also presented Mr. Dickson with a plaque on behalf of MEA for his many years of service.

# c. Superintendent Communication

Superintendent Kelley thanked the parents and staff members who spoke during public comment, and said he recognizes there is a great amount of frustration shared by him personally and professionally, as well as by the Board, as they continue to navigate ways to advocate for the students and staff of the district during the challenges presented by the pandemic.

## d. Board Member Communication

Board member Paul Diffley acknowledged the strength it takes for the members of the public in attendance to share their beliefs and concerns in a public meeting. He stressed the importance of listening to what was being said during public comment. Mr. Diffley suggested that the Board meet with the district's legal counsel to discuss consequences for disregarding the imposed COVID-19 mandates for students and staff. He stated that he would like to have some concrete facts to share with the staff and parents. Mr. Diffley shared his excitement to have the opportunity to attend plays in person again at Murrieta Mesa and Murrieta Valley high schools.

Board member Kenneth Dickson thanked the public speakers for providing good dialogue on the current public health mandates related to the pandemic. He reminded everyone to exercise their rights by voting in the upcoming elections. Mr. Dickson shared his heartfelt appreciation for the kind words he received from the community and staff about his years of service on the Murrieta Valley Unified School Board.

Board member Kris Thomasian said she could feel the care, passion and emotion in which the parents, teachers and staff members shared their comments about the COVID-19 mandates. She stated that she and her fellow Board members continue to advocate with the state officials on behalf of the MVUSD community. Mrs. Thomasian reported on the upcoming CSBA Delegate Assembly meetings on November 29 and 30, 2021. She highlighted the district Military Advisory Committee and the liaisons that interface with the military families in the district.

Board member Oscar Rivas thanked the members of the public who shared their stories with the Board this evening. He said he is really excited that the soccer season is starting, and he will be able to watch his son play. Mr. Rivas wished everyone a safe and happy holiday.

Board member Linda Lunn referenced a letter dated August 23, 2021, from the California Department of Public Health that said districts would be subject to significant legal and financial consequences if they choose not to follow public health mandates. Mrs. Lunn stated that school board members are not legislators and cannot make laws. She thanked the members of the public that stayed to listen to the Board member's comments.

# 6. Presentation Regarding Trustee Area Redistricting

Presenters: Bill Olien, Deputy Superintendent; Janet Mueller, Shareholder, Dannis Woliver Kelley; Justin Rich, Senior Director, Cooperative Strategies

Cooperative Strategies performed a demographic review of the 2020 Census data, as is required every ten years, which showed substantial changes in the area served by Murrieta Valley Unified School District from 2010 to 2020. They reported that the overall population growth during those years was 8.4%, resulting in a total variance between trustee areas of 15.9%. In order to remain in compliance, the total population distribution in trustee areas must be less than 10%. Cooperative Strategies will prepare potential maps of adjusted voting areas and present them to the Board for review at the January 20, 2022, Board of Education Regular meeting.

# 7. Discussion of Process Options for the Selection of a New Superintendent for the 2022/23 School Year

Jonathan Pearl, Shareholder, Dannis Woliver Kelley facilitated the discussion with Board members regarding options and best practices for the search and selection process for the new superintendent who will be replacing retiring Superintendent Kelley. The Board considered conducting the search internally and the option of hiring a search firm to look for the best possible candidates throughout the country.
