President Kris Thomasian called the Board of Education regular meeting to order at 4:30 p.m. at the Murrieta Valley Unified School District Support Center, 41870 McAlby Court, Murrieta, California.

2. Establishment of Quorum

A quorum was established with Takesha Cooper, Paul Diffley, Ellen Larson, Linda Lunn and Kris Thomasian present.

B. PUBLIC COMMENT REGARDING CLOSED SESSION ITEM

There were no comments submitted pertaining to the closed session item.

C. CLOSED SESSION

The Board adjourned to closed session at 4:30 p.m.

E. COMMUNICATIONS

1. Public Comment

Lucky Haratunian commented on campus safety, particularly at the elementary school sites.

2. Employee Organization Reports

Kimberly Binning-Chevlin, President, Murrieta Educators' Association extended a warm welcome to Dr. Andrus. She praised the Bargaining Committee and the District for the expeditious acceptance of the bargaining agreement and reported that Learn@Home and Elementary PE Teachers items remain open.

3. Superintendent Report

Dr. Andrus reported visiting seven school sites on the first day of school, five more sites today and plans to visit the remainder of the sites tomorrow. He praised the positive energy at the school sites from students, parents and staff, stating that it feels like a normal start to the school year and that the pandemic is not quite over, but we are in a much better position than last year. Dr. Andrus reported that current enrollment is at 22,500 students but there will be some fluctuations due to no shows and continued student enrollment. He addressed challenges with student transportation due to changes in school start times, driver shortages and new traffic patterns. Dr. Andrus closed his remarks by sharing the focus of the 2022/23 school year of Renew, Reignite, Reconnect.

4. Board Member Reports

Board member Dr. Takesha Cooper commented on how quickly the summer had gone by. She shared her excitement about the start of the new school year and the fact that the district is providing free breakfast and lunch again this year. She welcomed Dr. Andrus to his first school year at Murrieta Valley USD and said she is looking forward to his leadership.

4. Board Member Reports (continued)

Board member Linda Lunn welcomed everybody back to the new school year and assured the audience that the traffic issues would resolve as the school year progresses. She acknowledged the many extra hours the transportation department has been putting in on the weekends in order to work out the kinks this year. Mrs. Lunn welcomed Dr. Andrus and Mrs. Mutchnick-Jayx to their new positions and said she is excited to see what this school year holds.

Board member Paul Diffley extended a warm welcome to Dr. Andrus and expressed his pleasure at being able to see everybody's smiling faces without masks covering them. Mr. Diffley shared his appreciation for the transportation department's efforts and overtime to get the year started and for the custodians and groundskeepers as they continue to keep the schools looking clean. He commented on the great group of teachers and staff that are approaching this year with renewed excitement. Mr. Diffley said there was no activity from the County Committee on School District Reorganization to report.

Board member Ellen Larson reported attending the July administrative luncheon, and thanked Darren Daniel, Leigh Lockwood and Faythe Mutchnick-Jayx for their work on that very important and informative event. She thanked Dr. Andrus for taking the time to learn the culture of the district and for embracing the community. Mrs. Larson shared her pleasure with the new website design and thanked Monica Gutierrez for implementing the change over the summer. She reported that the first day of school went well for her grandchildren and that they were happy to be back in class with their friends. Mrs. Larson expressed her gratitude to all the staff for their hard work over the summer to make the first day of school such a success.

Board member Kris Thomasian recognized Mr. Diffley for his efforts to ensure the halls of the district office are lined with student artwork. Mrs. Thomasian stated how thrilled she is to have Dr. Andrus here in Murrieta Valley USD and shared her appreciation for the time he has spent getting to know the community and staff. She reported attending the inspirational, motivational and informative administrative luncheon in July and on her continued efforts at the state level in the area of home to school transportation funding. Mrs. Thomasian thanked the residents of The Linden for donating 150 backpacks to our foster and/or homeless students.

Mrs. Faythe Mutchnick-Jayx, Assistant Superintendent, Educational Services provided an update on summer programs offered to children ranging from 18 months old through high school, which provided services to 80 children in child development summer care, 200 transitional kindergarten - 5th grade students in SEED summer camp, 310 kindergarten - 5th grade students in elementary summer school, 167 special education students, 254 middle school students and 825 high school students. She reported on professional development and training provided to administrators, teachers and classified staff during the summer.

Mrs. Leigh Lockwood, Assistant Superintendent, Human Resources, shared student enrollment and staffing numbers for the 2022/23 school year, which included 210 personnel changes as of July 2022.

Mr. Darren Daniel, Deputy Superintendent, presented an overview of business and operations summer projects which included accounting close out of the 2021/22 fiscal year, purchasing, nutrition services, transportation, technology, and facilities maintenance projects completed during summer break.

Mrs. Monica Gutierrez, Public Information Officer, highlighted the new website design that was implemented over the summer.

Dr. Ward Andrus, Superintendent, concluded the reporting with an overview of his summer projects, which began with his move to Murrieta and then immersing himself in the community with school site visits, and meetings with community leaders and elected officials.
