a. Public Comment

Lucky Harutunian and Jolinne Cochran each commented on AB329 chapter 398 in opposition of sex education.

Kyle Davis commented on COVID-19 testing, isolation and quarantine protocols at the school site causing children to miss ten days of in-person instruction while waiting for test results.

Kimberly Auer and Tyler Clark each provided comment expressing their opposition of any reference to Critical Race Theory in the K-12 classroom setting.

Chantelle Grisez, Anthony DeMay, Nathan Abiel, Whitney Moylan, Allisa Nazar, Todd Donohoe, Karen Brann, Ariana Jacobs and Shawn S each provided comment opposing the public health mandates requiring students and staff to wear a face covering while in the classroom.

b. Employee Organizations Communication

Mrs. Binning-Chevlin, President, Murrieta Educators Association stated that she had nothing new to report.

c. Superintendent Communication

Superintendent Patrick Kelley encouraged the Board members to attend the events taking place at the school sites to commemorate the 20th anniversary of the terrorists' attacks on our nation.

d. Board Member Communication

Board member Kris Thomasian provided the CSBA Delegate Assembly Update, highlighting the efforts being undertaken to assist those school districts being affected by the wildfires and the work on the independent study program language.

Board member Oscar Rivas stated how pleased he is that the students are participating in classes in person and said his kids are enjoying being back at school.

Board member Paul Diffley provided an update from the Riverside County Committee on School District Organization regarding the current proposed property transfer from Banning to Beaumont. Mr. Diffley stated that he is thrilled to see performing arts return to the school sites. He also thanked the community members in attendance for providing their valuable comments.

Board member Kenneth Dickson thanked the participants for providing their comments and reiterated that Board members have significant powers as to how schools run and control of the district budget, however, they do not have the power to defy Public Health Orders. He encouraged participation in state level elections to bring about the changes that were mentioned in the public comments.

Board member Linda Lunn thanked the crowd for the level of decorum exhibited during the public comment portion of the meeting. She encouraged first responders and members of the military to attend the September 11th commemorative events taking place on the campuses.
