		The district is prohibited from requiring eligible students to graduate before the end of his/her fourth year.
		Graduation under AB 1806 does not provide the student with the requirements to be accepted into a 4 year university/college. The youth is eligible to attend a community college and utilize a course of study that will allow the student to transfer to a 4 year postsecondary institution.
		Graduation under AB 1806 may affect the student's eligibility for entrance into the military.
		If student is eligible for the exemption, they are not required to accept the exemption and cannot be denied enrollment in courses for which they are otherwise eligible.
		If the student is not eligible to graduate under AB 1806 upon initial evaluation; the student shall be granted an exemption any time if he/she requests and qualifies for it in the future.
		Once the AB 1806 exemption has been granted it cannot be revoked by the school district
