Employee Organization Communications

Kathy Ericson, President of the Murrieta Teachers Association (MTA), reported that despite the state's budget challenges teachers are focusing on their classrooms and leaving the collaboration to teacher representatives.

PTA Communications

Kelly Breen-Stottman, PTA Military Chair, reported that 6,497 valentines were prepared by Murrieta students as part of the Valentines for Vets Challenge. A traveling trophy will be presented to Alta Murrieta Elementary School tomorrow morning for submitting the most Valentines. Mrs. Breen-Stottman shared that 3,000 of the valentines will be headed for Bagram Air Base for men and women of our armed forces who are currently stationed in Afghanistan, the remainder will be distributed to veterans at retirement facilities, VFWs, and VA's at Balboa, Camp Pendleton and Loma Linda in time for Valentine's Day.

Superintendent Communications

Superintendent Scheer has been visiting schools on a regular basis and attending sports program. He complimented both staff and students for demonstrating C.L.A.S.S. (Character, Leadership, Attitude, Scholarship and Service) both on the court and in the classroom. He shared that he is so pleased with all of the positive things going on at our schools.

Board Communications

Trustee Ken Dickson stated that character, flexibility, goodwill, communication, and good faith have been the hallmark of this district and he is proud to be a part of it.

Trustee Margi Wray said that because failing to plan is planning to fail our planning is essential so that we don't fail kids. She thanked the PTA for organizing the Valentines for Vets Challenge.

Trustee Kris Thomasian stated that she is proud that the District has fulfilled its goal of keeping projects intact and people employed, and teachers and staff have done an amazing job of providing incredible opportunities for students. Ms. Thomasian expressed her appreciation to Ms. Breen-Stottman and the PTA for their work with the Valentines for Vets Challenge.

Trustee Robin Crist thanked Karen Parris, Media & Communications Specialist, for her work in communicating the District's activities to parents, staff and the community. She encouraged everyone to attend a school pep rally, and praised students for their efforts to put these exciting events on. She announced that scholarship applications are due February 14th, with the Scholarship Awards Night scheduled for April 30th.

Trustee Paul Diffley reported visiting classrooms during the past two weeks, and each time he left excited and commented that that's where a lot of it happens. He referred to the phrase "it was the best of times and the worst of times" and said that this phrase is applicable today with the worst of times relating to Sacramento. He indicated that he and Mrs. Wray recently attended an MTA meeting and remarked that there was not a feeling of hostility or depression amongst teachers; it was a feeling that we are going to be okay which has inevitably has an effect on students. He thanked staff for providing a great education to the students of Murrieta.
