**Public Session / Report out of Closed Session**

President Diffley reconvened the meeting into public session at 5:31 p.m. He reported that the Board met in Closed Session to discuss student discipline and that no actions were taken.

**D-1: Expulsion of High School Student Number 231-013-520**

**MSCU CRIST/WRAY** that the Board of Education of the Murrieta Valley Unified School District, under Education Code 48915 (b) and (e), expels student #231-013-520 from all schools in the district based on Board Policy 5144.1, for the violation of Education Code 48900 (a2) and (k), for the remainder of the first semester, and the entire second semester of the 2011-2012 school year.

The enforcement of the expulsion will be suspended for the entire second semester, based upon the completion of the conditions for readmission and the student's and parent's agreement with the terms and conditions of the education placement determined by administration during the term of the expulsion.

**D-2: Expulsion of High School Student Number 380-000-703**

**MSCU WRAY/THOMASIAN** that the Board of Education of the Murrieta Valley Unified School District, under Education Code 48915 (b) and (e), expels student #380-000-703 from all schools in the district based on Board Policy 5144.1, for the violation of Education Code 48900 (a1) and (k), for the remainder of the first semester, and entire second semester of the 2011-2012 school year.

The enforcement of the expulsion will be suspended based upon the student's and parent's agreement with the terms and conditions of the education placement determined by administration during the term of the expulsion.

**D-3: Approval to Readmit Expelled Student into the Murrieta Valley Unified School District for the First Semester of the 2011-2012 School Year**

**MSCU DICKSON/WRAY** to readmit expelled middle school student #956001583 into the Murrieta Valley Unified School District for the first semester of the 2011-2012 school year.
