B-1: Board Workshop on Energy Management Bill Olien, Assistant Superintendent, Facilities/Operational Services introduced Rick Thomason, Green Schools; Maya Aubrey, Southern California Edison; Matt Willard, Vista Murrieta High School teacher; Pam Brown and Jared Rogers, Creekside High School; and Terry Gavitt, McElhinney Middle School.

Mr. Olien reviewed the energy savings programs the District has already implemented as well as current projects underway. His report detailed the pros and cons and approximate cost savings of solar energy, load shedding programs, and equipment upgrades.

Darrin Waters with the Dolinka Group provided an overview of the school facilities financing plan and a possible funding plan for a district solar project.

Clyde Murley, Independent Energy Consultant to the district discussed the economics and procurement of solar electric systems.

After a lengthy discussion, the Board gave direction to Mr. Olien to move forward to receive proposals on a district wide solar energy plan.
