**Employee Organization Communications**

Craig Frame, President of the California School Employees Association (CSEA) Murrieta Chapter 223 commended the Board of Education for holding the Community Budget Forum. He thanked Pat Kelley and Stacy Coleman for the many hours they spent helping reach the tentative agreement that will save jobs and protect programs.

Chuck Smith, President of the Murrieta Teachers Association was pleased to report that the bargaining team had come to an understanding and he hoped to sign a tentative agreement soon that will go to the membership for a vote. He also thanked Pat Kelley and Stacy Coleman for their help facilitating the tentative agreement.

**Superintendent Communications**

Superintendent Scheer congratulated Alta Murrieta, Cole Canyon and Buchanan elementary school for being named California Distinguished Schools. He thanked Principal Darren Daniel and the staff of Vista Murrieta High School for hosting the very well attended Community Budget Forum. He expressed his appreciation to both associations for coming together to meet the difficult challenge imposed by the State of California. He commended the High School Athletic Directors, in particular Ray Moore from Vista Murrieta High School, for establishing an athletic foundation to raise funds in support of our athletic programs.

Trustee Ken Dickson shared that the Community Budget Forum was a very positive meeting and he was pleased that students attended and participated in the meeting.

Trustee Margi Wray indicated that the Community Budget Forum served as an opportunity for the community and staff to speak their minds, as well as for the Board to listen and answer their concerns.

Trustee Kris Thomasian remarked that up to this point the district has shielded students and parents from the devastating impact of the state budget and encouraged students present at the Board Meeting to contact senators, assembly members and the Governor to let them know that cutting funding to education is not acceptable. Mrs. Thomaisan expressed her appreciation to staff for pulling together to do the best we can given the circumstances. She shared that she was invited to participate in the National School Boards Association conference in Chicago as panel member discussing the role of the School Board when implementing academic study of the bible. She noted that no district funds were used to pay for the conference or her travel.

Trustee Paul Diffley stated that Monday night's Community Budget Forum was a terrific example of "democracy at the ground level" noting that local control of schools is very important. He expressed his gratitude to Dr. Scheer and administrators for their efforts.

Trustee Robin Crist commented that she is proud of the community for attending the Budget Forum and being honest about their comments. Ms. Crist announced that the Scholarship Awards Night will be held on May 18 at the Revival Christian Fellowship Church. She thanked the students of Antelope Hills Elementary School and Vista Murrieta High School involved in the Explorer Program.
