**B-2: Information regarding Certificated Employee Layoffs**

Assistant Superintendent Pat Kelley provided information regarding timelines and the layoff process, and reported that 159.18 full time certificated staff could potentially receive lay-off notices by March 15, 2010, in response to the \$14 million budget shortfall the district faces.

Mr. Kelly told the Board that negotiations with the employee groups are continuing, and that MTA and the District are committed to the goals of maintaining a quality educational program and keeping those who provide services to students, working to the greatest extent possible.

The enforcement of the expulsion will be suspended based upon the student's and parent's agreement with the terms and conditions of the education placement determined by administration during the term of the expulsion.
