**2. Summer Reporting**

Faythe Mutchnick-Jayx, Assistant Superintendent of Educational Services, updated the Board on summer programs offered to children ranging from 18 months to 22 years old, which provided services to 143 TK - 5th grade students in SEED summer camp, 67 children 18 months to 4 years old at the child development center, 350 K-5th grade students at elementary summer school, and 610 students at high school summer school with 17 summer graduates.
