1. Student Representative Reports

Vista Murrieta High School student, Brycen Ruud, reported on academics, athletics, activities and upcoming events.

2. Public Comment

Karen Poznanski and Jamie Goebel and Jameson LeRossignol commented on Mr. Pardue's previous criticism of students' writing skills and district English Teachers' performance. They said his comments were uninformed, unjust and insulting to the hard-working teachers in the district.

Art Amor and Teresa Wells expressed their displeasure with the three newly elected school board members' performance and their focus on an "extremist agenda".

Jose Carreno expressed his support for the three newly elected school board members and shared his dissatisfaction with harsh public criticism they have been facing for some time.

Kathryn "Josh" Wehus and Diana Hansen commented about the recently adopted parental notification policy and shared concerns that it could lead to unsafe situations for LGBTQIA+ students.

Najah Roberts and Shawni Rhodan shared concerns about bullying, racism and negative school culture.

3. Superintendent Report

Superintendent Andrus commended the staff and students on the completion of a successful first semester. He reported on the District's shift in messaging from "college for all" to focusing on preparing students for various post-high school credentials, including apprenticeships, college and trade schools. Dr. Andrus stated that the district is enhancing and expanding the current career pathway offerings to support this change in focus. He also highlighted the special report about district facilities being mailed to the community in January and encouraged everyone to complete the survey about the physical needs of the schools and district facilities.

4. Board Member Reports

Trustee Nicolas Pardue expressed his love for the Christmas season and appreciation of the sense of community and family the season brings. Mr. Pardue stated that as a school board member he focuses on academic standards, advocates for parental concerns, addresses teacher politics, and questions whether the education system delivers what taxpayers pay for. He stated that it is crucial for the community to engage in civil conversations about where one student's rights end and another's begin.

Trustee Nancy Young reported attending the district's LPAC meeting, Rotary Club meetings, California School Boards Association Annual Education Conference in San Francisco, visiting Lisa J. Mails Elementary and Monte Vista Elementary, attending the Walk Through the American Revolution and Murrieta Elementary and participating in the Project 99 fundraiser walk. Ms. Young encouraged Murrieta Valley USD senior students to apply for the Murrieta Dollars for Scholars scholarship.

Trustee Julie Vandegrift reported attending the Student of the Month Breakfast, the Measure BB Citizens' Oversight Committee meeting, and visiting Cole Canyon Elementary and Murrieta Valley High. She spoke about Assembly Bill 2158 which takes effect January 1, 2025, requiring School Board members to complete ethics training for the purposes of familiarizing themselves with general ethics principles, laws, conflicts of interest, transparency, fair processes and prerequisites of office.

Student Board Member, Isabella Dadalt said that students are preparing for upcoming finals and are ready for the end of the first semester. She said the next report from the Superintendent Student Advisory Council would be provided in February, after their January meeting.

President Diffley said he has been learning about changes happening in the city which eventually affect the school system. He reported attending several visual and performing arts performances at the school sites and shared his appreciation for the dedicated teachers who help to develop the student's acting, singing and stage presence. Mr. Diffley reported attending the Latino parent advisory committee and African American parent advisory committee meetings.

Trustee Linda Lunn reported attending the African American Parent Advisory Committee's "Taste of Africa" event, California School Boards' Association Annual Education Conference in San Francisco, participating in the annual Share the Harvest event and Project 99 walk, speaking about the role of a Board member to the first year CTE Education pathway students. Mrs. Lunn thanked Council member Lori Stone for working with the district to include the Adult Transition Students and their coffee cart in the upcoming "A Day in Her shoes" event at Murrieta Hot Springs Resort.

Kimberly Binning-Chevlin, President, Murrieta Educators Association, reported that MEA members actively participated in the Murrieta Festival of Trees by purchasing and decorating Christmas trees which were then given to Murrieta families in need and participated in the Project 99 event. Mrs. Binning-Chevlin reported that the District and MEA are fully engaged in negotiations with recent discussions focused on the district's financial standing.

Freddie Musquiz, President, California School Employee Association, Murrieta Chapter 223, reported that he continues to work with members to address concerns. He said they are also preparing for negotiations and aim to provide beneficial outcomes. Mr. Musquiz invited board members to speak at the January 8th CSEA meeting.


