State and federal law allow the District to release directory information about your child to the following individuals, officials, agencies and non-profit organizations upon request and without your prior consent: companies that manufacture class rings or publish yearbooks, post-secondary educational institutions, county and state educational agencies, military recruiters, federal programs for the purpose of data reporting, third party providers of online educational tools used for educational purposes and news media. The district cannot restrict students' right to speak freely with the media or consent to be voluntarily photographed or interviewed.

The District also publishes directory information about students for the purpose of providing the community with information about activities, events, school awards, assemblies, academic and co-curricular programs. District or school sponsored publications may include school and district newsletters, web sites, video productions, news releases and district-related social media sites.

Directory information may include the student's name; address; phone number; e-mail address; photograph; date and place of birth; major field of study; grade level; enrollment status; dates of attendance; participation in officially recognized activities and sports; weight and height of members of athletic teams; degrees, honors and awards received; and the most recent educational agency or institution attended. State and federal law allow parents/guardians to opt out of the District's release of directory information to these outside individuals and organizations.

If you do not wish to have directory information about your child published or released, you must opt-out by filling out this form and returning it to the school office within the next 30 days.

The District does not release directory information regarding homeless children or youth as identified by the McKinney – Vento Homeless Assistance Act, unless the parent, or homeless child or youth over the age of 14, provides written consent that such directory information may be released.
